BACKGROUND

- December 16, 2014 City Council approved acceptance of:
 - Cool California Challenge Competition grant funds in the amount of \$32,950
 - Green Business Program grant funds in the amount of \$30,000

COOL CALIFORNIA CHALLENGE COMPETITION

- Competition between 10 California cities to motivate and reward residents for reducing their carbon footprints and helping to build a more vibrant community
- More than 1,150 Riverside residents earned the City over 3.2 million points, earning \$32,950 for the City to put toward sustainability projects
- The program required award of funding following a competitive process to a community group (Wood Streets Green Team) for development of a community garden, solar bench, tree planting, and a workshop

DISCUSSION GREEN BUSINESS PROGRAM

- Program for the creation and setup of a Green Business Program in Riverside
- Riverside was one of three selected recipients
- Program provides technical advice to help businesses implement pollution prevention and conservation measures and institute policies to improve long-term environmental practices
- Funds were used for program dues, marketing materials, and plaques for certified businesses

DISCUSSION

- Funds were appropriated into Electric Fund State Operating Grants accounts and administered by RPU Customer Engagement on behalf of the City's overall sustainability program
- Programs were paused for staff to focus on drought programming beginning in 2016 and then due to citywide hiring limitations from COVID-19 beginning in 2020

DISCUSSION

- The approved FY 2022-24 Biennial Budget includes two new positions for the Office of Sustainability (OoS) of the City Manager's Office
- Remaining grant funds of \$24,676 (Cool California) and \$9,440 (Green Business) will be administered by OoS
- The change to OoS necessitates a transfer of the funds from the Electric Fund to the Grants and Restricted Programs Fund
