#### 3. EXECUTIVE DIRECTOR'S REPORT

## A. Working Group Update

Mr. Webster reported to the Board that the annual conference registrations are coming in slower than anticipated and expressed hope that the number of attendees will increase as it is a valuable conference for all members.

Mr. Webster shared that the Assistant General Manager (AGM) working group meeting restarted and thanked the Board Members for their support in facilitating the start of the group. He reported that AGMs generated lot of ideas including discussions on long-term communication strategies with regulators and legislators on the challenges, issues, and successes on reaching 100% clean energy, setting up training workshops, and potential new working groups.

Lastly, Mr. Webster shared SCPPA's no-cost partnership with Global Energy RE+ for its upcoming conference on September 11-14, 2023, which allows any SCPPA member to receive 30% savings on registration.

## B. Report regarding Individual Meetings with Members

Mr. Webster thanked the Board for taking the time to meet with him and Ms. Godinez to assess member needs of SCPPA. He provided a high-level summary of Member-provided suggestions regarding distribution, programs, and other strategic opportunities including workshops and training. Boardmember Dukku Lee requested that SCPPA staff evaluate which of the proposed distribution programs are within the scope of SCPPA's powers. In response to Boardmember questions, Mr. Webster stated that the proposed new initiatives and programs are not budgeted nor proposed for approval or implementation and would require additional staffing and further Board input and approval if the Board were to proceed.

## 6. GOVERNMENT AFFAIRS DIRECTOR'S REPORT

## A. State Regulatory Update

Ms. de Jong presented a state regulatory update, including activities on the California Air Resources Board (CARB) Cap-And-Trade and noted that comment letters are due on August 17, 2023. Ms. Seitzman presented a high-level update on regionalization and provided an update on the guidelines that dropped for the Distributed Electricity Backup Assets (DEBA) program that provides \$545 million for emergency backup assets and noted that 25% of the total award will be set aside to POU project territory. Ms. de Jong and Ms. Seitzman answered questions from the Board of Directors.

## **B. State Legislative Update**

Mr. De Bernardo presented a state legislative update including bills on Advanced Clean Fleets and Central Procurement and Capacity Payments.

## C. Federal Issues Update

Mr. De Bernardo presented a federal issues update, including the Inflation Reduction Act proposed regulations and actions on supply chain issues regarding transformers.

## D. Long-term Advocacy Strategy on 100% Clean Energy Goals

Mr. De Bernardo presented a long-term advocacy strategy on 100% clean energy goals. He concluded his report by announcing that SCPPA is planning a November/December Southern California field trip for California Energy Commissioners & senior advisors to discuss clean energy discussions and objectives.
