## City of Riverside Board and Commission Member Attendance Report - 2024

Board/commission members shall make every effort to notify the Chairperson or his/her designee no later than 24 hours prior to any regular meeting of his/her intent not to attend said meeting. A member's inability to provide 24 hours advance notice shall not preclude the board/commission from exercising its discretion to excuse said absence as outlined in Section 805 of the City Charter. If a member of a board or commission obsents himself/herself from three consecutive regular meetings of such board or commission, unless by permission of such board or commission expressed in its official minutes, or is convicted of a crime of moral turplitude, or ceases to be a qualified electror of the City, the office shall become vacant and shall be so declared by the City Council. The City Clerk shall provide provide seats and the appropriate Councilmember for Ward specific seats for direction to be taken in the event of either of the following conditions: (a) a board/commission member is absent unexcusted from three consecutive regular meetings of the board/commission member is absent, whether excused or unexcusted, from more than one-third of the regularly scheduled meetings in any calendar year.
