Brown Act Complaint

I write in response to the complaint filed against me alleging violations of the Riverside Code of Ethics and Conduct and the Ralph M. Brown Act. After careful review of the allegations and supporting materials, I respectfully submit that the complaint is factually inaccurate, legally insufficient, and should be dismissed. It is also important to note that attorney Damian Martin, whose sworn declaration forms the backbone of the complaint, is now under investigation by the California State Bar Association for the accuracy of his statements in this very case.

I. The Brown Act Allegation Is Factually False

The complaint's central premise is that four City Councilmembers, including myself, were present together at the March 13, 2025 Chamber of Commerce "Good Morning Riverside" event, thereby constituting a majority in violation of the Brown Act.

This claim is demonstrably false. I have definitive proof that Councilmember Jim Perry, who is alleged to have been present, was not in attendance at the event. This fact is verifiable and indisputable. At most, only three councilmembers were present.

Under California Government Code §54952.2(a), a "meeting" requires the presence of a majority of the legislative body. The Riverside City Council consists of seven members; a majority requires at least four. With only three present, no quorum existed, and no Brown Act "meeting" could have occurred. The alleged violation is therefore factually impossible.

II. The Supporting Declaration Is Inaccurate and Unreliable

The complaint relies heavily on a sworn declaration by Mr. Damian Martin, who stated under penalty of perjury that he personally observed Councilmember Perry at my table during the March 13, 2025 Chamber event. This statement is categorically untrue.

The inaccuracy of Mr. Martin's declaration undermines the credibility of the complaint as a whole. If the declaration is false on such a material point, the Board should view with skepticism the remainder of the speculative and unsupported allegations contained in the filing.

Furthermore, because of the seriousness of submitting false testimony under oath, Mr. Martin is now under investigation by the State Bar of California regarding his sworn declaration in this case. This fact further demonstrates that the foundation of the complaint is deeply compromised.

III. One-on-One Staff Briefings Do Not Constitute a Brown Act Violation

The complaint further alleges that City staff engaged in sequential meetings with councilmembers prior to January 7, 2025 regarding potential amendments to the cannabis ordinance. These claims mischaracterize standard staff-council interactions.

The Brown Act expressly permits staff to brief councilmembers individually, so long as staff does not act as an intermediary to communicate the views of one member to another. There is no evidence of such "collective concurrence" here. Informational briefings are lawful, routine, and essential to good governance.

IV. No Evidence of Prohibited Conduct Under RMC §2.78.060

The complaint cites numerous provisions of Riverside Municipal Code §2.78.060, including alleged misuse of position, ex parte communications, or conflicts of interest. Yet it fails to provide any evidence that I:

- 1. sought personal or financial gain,
- 2. coerced or influenced city staff improperly,
- 3. engaged in prohibited communications, or
- 4. assisted others in violating the Code of Ethics.

Instead, the complaint attempts to conflate staff communications and private party lobbying with my conduct as a councilmember. There is no nexus to me personally, and no evidence that I violated any prohibition under the City's Code of Ethics and Conduct.

V. Policy Changes Are Not Misconduct

The complaint also suggests impropriety simply because certain councilmembers, including myself, reconsidered our positions regarding the number of cannabis dispensaries allowed in the City. This claim is without merit.

Elected officials routinely reevaluate their policy positions in light of new information, evolving community concerns, or legal guidance. Policy development and change are fundamental aspects of representative government, not evidence of misconduct.

VI. Burden of Proof Not Met

Under Riverside's Ethics procedures, the burden of proof lies with the complainant, who must establish a violation by a preponderance of the evidence. Here, the allegations are speculative, factually flawed, and unsupported by credible evidence. The complaint not only fails to meet this standard but is founded on a demonstrably false claim regarding Councilmember Perry's attendance and a sworn declaration that is now under professional investigation.

VII. Conclusion

The complaint is built on a false premise, relies on an inaccurate sworn declaration, and fails to provide evidence of any actual misconduct. It should therefore be dismissed in its entirety.

I respectfully request that the Board of Ethics reject this complaint and affirm the importance of ensuring that Riverside's ethics process is not misused for political or legal gamesmanship.



On July 29, 2025 Mr. Martin, under penalty of perjury, signed and executed a sworn declaration in the case:

TAT RV, LLC, a California limited liability company; OTC RIVERSIDE, LLC, a California limited liability company; PACKS RIVERSIDE, LLC, a California limited liability company; Petitioners and Plaintiffs, vs.
CITY OF RIVERSIDE, a California charter city and municipal corporation; DOES 1-20, inclusive,

Within that declaration, which was used in a city ethics complaint against myself and three other Councilmen (Perry, Conder & Robillard), he made completely false allegations accusing the four of us of violating the Ralph M. Brown Act. According to Mr. Martin's sworn declaration he states, "During the Riverside Chamber's Good Morning Riverside event on March 13, 2025, I personally observed that Mill was seated at the same table as Riverside City Councilmembers Steven Robillard, Chuck Conder, and Jim Perry."

Based on this sworn statement by Mr. Martin all four Councilmen, including myself, were brought up on ethics charges. There is only one problem, this statement is completely false. Councilman Perry was not at the event and I have a sworn declaration from him attesting to that and I also have the registration and sign in sheet, provided by the Greater Riverside Chamber of Commerce, that proves Councilman Perry was not in attendance.

As an officer of the court Mr. Martin should be held to the highest standards and filing a knowingly false declaration with the courts and as part of a City of Riverside Ethics complaint should not be tolerated. Mr. Martin did so for political retribution in an attempt to punish elected officials because his client did not get one of our city's cannabis licenses.

I will be including evidence showing Mr. Martin's claim is false.
