Following a majority vote, Commissioner Gutierrez accepted the position of Vice Chair.

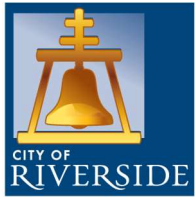

### ABSENCE OF MARCH 26, 2025, REGULAR MEETING

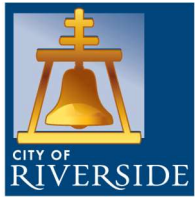
The Community Police Review Commission recorded the absence of Commissioner Lundy from March 26, 2025, regular meeting as excused.

#### CONCLUDE STAGE 1 AND PROCEED TO REVIEW STAGE 2 OF THE CRIMINAL CASE BOOK FOR OFFICER INVOLVED DEATH CASE #2022-00362 AND #MB22 019 0001 - J. TRACY

Community Police Review Commission Independent Consultant Frank Hauptmann opened the review of Stages 1 and 2 of the Criminal Case Book for Officer Involved Death Case #2022-00362 and #MB22 019 0001 - J. Tracy. Mr. Hauptmann provided the Commission with an update on the public records requests submitted to the Riverside County Sheriff and Hemet Police Department for any and all body worn camera videos, Closed Circuit Television videos, and photos pertaining to OID involving J. Tracy and continued with a summary of the investigation and applicable investigative reports.

Following discussion, it was moved by Commissioner Dillon and seconded by Vice Chair Gutierrez to (1) conclude review Stage One of the Criminal Case Book for Officer Involved Death case #2022-00362 and MB22 019 0001 - J. Tracy; and (2) begin Stage Two - Fact Finding, Request for Training & Investigation of the Officer Involved Death case #2022-00362 and MB22 019 0001 - J. Tracy. If the Commission requests important facts to be discussed, for clarification on policies, practices, and procedures, or request additional training or additional investigation that it be presented at the April 23, 2025, Community Police Review Commission meeting. #### BRIEF REPORTS ON CONFERENCES, SEMINARS, AND MEETINGS ATTENDED BY CPRC

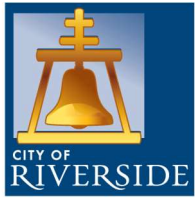
There were no reports on conferences, seminars, and meetings attended by the Commission members.
