

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH TIMED NO
5 PARKING BUS LOADING ZONE ON A SEGMENT OF MYERS STREET.

6 WHEREAS, the Public Works Department received a request from the residents of 3761
7 Myers Street to establish a timed No Parking Bus Loading Zone just south of the shared driveway
8 which serves 3761, 3763, 3767, and 3769 Myers Street; and

9 WHEREAS, the establishment of the zone is intended to provide unobstructed access to
10 curbside loading for a 24-foot long school bus which provides special transportation service for the
11 disabled student at the property Monday through Friday (except for holidays) to and from school
12 during both regular and summer school sessions; and

13 WHEREAS, existing conditions allow for vehicular parking within this area of Myers
14 Street, which is frequently utilized by area residents and/or patrons of the nearby businesses, often
15 impeding curbside bus access to the property; and

16 WHEREAS, restricting parking during scheduled school bus pick-up and drop-off times
17 would provide immediate bus access to the property and facilitate the safe and efficient loading
18 and unloading of the disabled student while allowing for vehicular parking during non-restricted
19 days and time and alleviating any impacts to the adjacent shared driveway; and

20 WHEREAS, on August 6, 2025, the Transportation Board unanimously approved staff's
21 recommendation to establish a timed No Parking Bus Loading Zone on the east side of Myers
22 Street from 285 feet south of Magnolia Avenue to 30 feet southerly thereof.

23 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
24 California, as follows:

25 Section 1: The recitals set forth above are incorporated herein by reference.

26 Section 2: That the Master Parking Schedule is hereby amended by establishing the "No
27 Parking between the hours of 7:00 a.m. to 8:00 a.m. and 12:30 p.m. to 3:00 p.m. Monday through
28 Friday except Holidays, Bus Loading Zone" on the east side of Myers Street from 285 feet south
of Magnolia Avenue to 30 feet southerly thereof.

Section 3: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.

Section 4: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
