

1 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA,  
2 AMENDING TITLE 9 OF THE RIVERSIDE MUNICIPAL CODE BY  
3 AMENDING SECTION 9.08.165 REGARDING THE PARKING OF  
4 RECREATIONAL VEHICLES IN CITY PARKS

5 The City Council of the City of Riverside does ordain as follows:

6 Section 1: Section 9.08.165 of the Riverside Municipal Code is hereby amended as  
7 follows:

8 **“Section 9.08.165 Parking of recreational vehicles in City parks.**

9 No person, group or entity shall park a recreational vehicle as defined in Section 10.04.132 within a  
10 park or recreation area owned or controlled by the City during said park or recreation area’s non-  
11 operational hours as set forth in Section 9.08.110(A) without first having obtained a permit from the  
12 Parks, Recreation and Community Services Director pursuant to Section 9.08.120 or otherwise  
13 obtained the permission of the Parks, Recreation and Community Services Director.”

14 Section 2. The City Council has reviewed the matter and, by based upon the facts and  
15 information contained in the staff reports, administrative record, and written and oral testimony,  
16 hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2),  
17 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations,  
18 Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical  
19 change.

20 Section 3. The City Clerk shall certify to the adoption of this ordinance and cause  
21 publication once in a newspaper of general circulation in accordance with Section 414 of the  
22 Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the  
23 date of its adoption.
