THE CITY OF RIVERSIDE, CALIFORNIA, ORDINANCE OF TITLE 9 OF **AMENDING** THE RIVERSIDE MUNICIPAL CODE **AMENDING** SECTION 9.08.165 REGARDING THE PARKING RECREATIONAL VEHICLES IN CITY PARKS

The City Council of the City of Riverside does ordain as follows:

Section 1: Section 9.08.165 of the Riverside Municipal Code is hereby amended as follows:

## "Section 9.08.165 Parking of recreational vehicles in City parks.

No person, group or entity shall park a recreational vehicle as defined in Section 10.04.132 within a park or recreation area owned or controlled by the City during said park or recreation area's nonoperational hours as set forth in Section 9.08.110(A) without first having obtained a permit from the Parks, Recreation and Community Services Director pursuant to Section 9.08.120 or otherwise obtained the permission of the Parks, Recreation and Community Services Director."

Section 2. The City Council has reviewed the matter and, by based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change.

Section 3. The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
