The minutes of the meeting on May 22, 2024, were approved as presented.

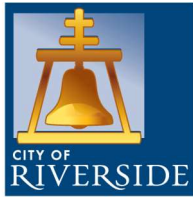
### COMMUNICATIONS REPORT
