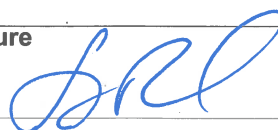

SCOPE OF SUPPLY

1) PACKAGING

A. Item(s) must be delivered in the manufacturer's original packaging with appropriate packaging surrounding

2) FILL RATE

A. Supplier shall maintain a minimum 98% fill rate.

3) PROVIDE PRODUCTS AS DETAILED IN EXHIBIT C

4) ADDITION(s) OF NEW ITEM(s) TO PRODUCT LINE

A. If during the contract period any new product is added to the manufacturer's product line, the County shall be offered the same discount as previously awarded comparable item.

B. If during the contract period, products which are not listed in Exhibit C are added, a minimum discount percentage off list price as indicated in Vendor's bid will apply.

EXHIBIT "B"
WEB-BASED ORDERING SYSTEM

WEB-BASED ORDERING FUNCTIONALITY

Vendor must provide a secured, web-based, ordering system with the ability for Riverside County Fire (FIRE) to administer without the assistance of the Vendor. The system shall provide, at minimum, the following features:

- 1) Administration Rights for authorized FIRE representative(s) with the following functionality without the assistance of the Vendor
 - a. Administrator shall authorize FIRE users of the system to include
 - i. Create User Names
 1. The user name must be tied to an employee ID number or specified email
 2. User name cannot be duplicated or deleted (only de-activated)
 3. Assign or change functionality rights
 - ii. Create, Assign, Re-set, or freeze (place on hold) a User Password
 - iii. Create a specific Supply List that can be assigned to FIRE users
 - iv. Limiting FIRE users to the ability to only order from Administrator approved Supply List
 - v. Approve and Add, Freeze (temporary HOLD), or De-Activate items available for purchase by FIRE users (based on Contracted pricing lists)
 - vi. Assign a "Category Code" to each item assigned the Supply List
 1. Categories include: Pharmaceuticals, BLS Equipment, ALS Items, etc.
 2. Administrator can create additional categories and supply lists
 - vii. Review, Modify, Approve, or Reject an Order (shopping cart) created by a FIRE end-user
 - viii. Reject an Order already submitted to Vendor (requirement to work with vendor representative in this case is acceptable)
 - ix. Run On-Demand reports to include, but not limited to
 1. Overall department ordering history
 2. History by item, category, or ship-to location
- 2) Authorized FIRE Users can log into system and view item pricing specific to FIRE
- 3) System provides a "shopping cart" for each user
 - a. Vendor will assign each shopping cart a unique identifying reference number/code

- b. Users can create multiple shopping carts with the ability to edit or delete a shopping cart prior to submitting an order
 - i. Users can review their shopping cart(s) history(s)
 - ii. Shopping carts can be “saved” to continue ordering process at later date or log-in
- 4) Order Review – Prior to Submittal to Vendor
 - a. Users can select from a list of names of FIRE order approvers (to be provided to Vendor)
 - i. User “submits for approval” to this FIRE order approver via email within web-ordering system.
 - 1. OR has the ability to copy/paste this information into an email, obtain approval, and ATTACH an email or a PDF document to the shopping cart order which remains as permanent history with the shopping card/order
 - ii. FIRE approver responds with approval or rejects with comments
 - 1. If approved, the User can submit the order to a County Purchasing Agent and include the approval as an attachment
 - 2. If rejected, the user can modify the shopping cart and re-submit for approval
- 5) FIRE Authorization to Vendor to submit shopping cart for order
 - a. FIRE user will submit a shopping cart with attached approval to Vendor which will simultaneously submit the shopping cart to a designated email address for an Authorized FIRE Purchasing Agent (e.g. Vendor_FIRE_Buyer@fire.ca.gov) to create a Purchase Order.
 - b. The Authorized FIRE Purchasing Agent will then submit a Purchase Order to the Vendor referencing the shopping cart(s) unique reference number(s)
 - i. This is the formal Authorization by the County to process the shopping cart as an order / fulfillment request.
 - c. Orders can be received and shipped the same day up until 5pm PST
- 6) ORDER CONFIRMATION
 - a. Vendor will send an order confirmation via email to include a shipment tracking number
- 7) ORDER SHIPMENT
 - a. All pharmaceuticals shall ship with an expiration date no less than 12 months after date of shipment.

- b. After market and expired drugs of any type will not be accepted.
- c. In-stock shipments shall have an estimated time of arrival to customer no more than five (5) calendar days after order is placed.
- d. Vendor shall itemize all invoices to include quantity, unit of measure, box count, package count, and separate ALS from BLS items, purchase order number etc and include detailed packing slips with all shipments.

8) ORDER RECEIPT

- a. Vendor will provide FIRE authorized user to electronically ACCEPT or RECEIVE the shipment upon receipt and review of the shipment in the web-based system.
 - i. This will also allow for reporting of discrepancies
