

## LOCATION MAP



## VIOLATIONS OF CONDITIONS OF APPROVAL

Condition No. 5, Planning Case P17-0126 (MCUP) –

- Compliance with Title 7 (Noise)
  - Multiple citations related to excessive noise
  - Operation beyond permitted hours and maintain amplified music with doors and windows open.

Condition No. 14, Planning Case P17-0126(MCUP) –

- Compliance with all Federal, State and local laws and cooperation with RPD
  - Unpermitted Tobacco Sales
  - CDTFA Tobacco License, and RPD permits are required

# VIOLATIONS OF CONDITIONS OF APPROVAL

Condition No. 26, Planning Case P17-0126(MCUP) –

- Security Plan
  - Insufficient security staff
  - unbonded security staff
  - Incidents with security staff

Condition No. 27.c , Planning Case P17-0126(MCUP) –

- Camara Security Footage
  - noncooperation and obstruction
  - Security system does not meet minimum standards

# VIOLATIONS OF CONDITIONS OF APPROVAL

Condition No. 13, Planning Case P17-0126(MCUP) –

- Operated or maintained in a manner detrimental to the public health, welfare or materially injurious to public safety, property or improvements in the vicinity or if the property is operated or maintained so as to constitute a public nuisance.
  - Downtown Experiment has created an environment which threatens the safety of patrons and the general public visiting Riverside's Downtown Entertainment District; and
  - RPD determined that Downtown Experiment has generated an extraordinary number of calls for services

## EXTRAORDINARY CALLS FOR SERVICES

1. The Riverside Police Department compiled a list of all police responses to Downtown Experiment for a five year period (January 01, 2020 through October 28, 2025).
2. The bar and nightclub generated a total of 504 calls for police service
3. A total of 99 police reports were generated.
4. Routine calls were excluded (alarm calls, parking problems, bar checks, etc.).

Staff recommends that the Planning Commission:


- 1. DETERMINE** that the proposed project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15321 (Enforcement Actions by Regulatory Agencies) of the CEQA Guidelines, as the proposed project will not have a significant effect on the environment;
- 2. APPROVE** Planning Case PC-2026-00117 revoking Minor Conditional Use Permit P17-0126 and associated Public Convenience or Necessity Determination P17-0503 for bar and nightclub uses with entertainment and on-sale of alcohol based on the findings outlined in the Staff Report ; and
- 3. ADOPT** the Resolution revoking the bar and nightclub uses with entertainment





## FLOOR PLAN


(Reference Only)


