October 15, 1998, Model Deaf Community was brought up by Mayor Loveridge. Then officially in 1999, it was a standing committee (stand-alone)






The City of Riverside – City Manager's Office – Megan Stoye helped draft a new proposal; to be part of the 18 City of Riverside's Boards/Commissions.
