

Arlanza

- 01/04/26 Incident report and exclusion notice issued to patron for 90 days for vandalism, unreasonable use of restrooms, failing to maintain personal hygiene, and engaging in activity and behavior that is disruptive.
- 01/07/26 Incident report excluded patron came into Arlanza, and threatened staff, as well as harassing several staff members. New exclusion will be issued for 365 days.
- 01/07/26 Incident report and exclusion issued for 365 to returned excluded patron for harassing Staff and Customers.

Arlington

- 01/02/26 Incident report and exclusion notice issued to an individual for 90 days for consuming alcohol on library premises
- 01/04/26 Incident report and exclusion notice issued to patron for 90 days for harassing staff at desk. Patron also harassed two other customers that were using computers.
- 01/15/26 Incident report and exclusion notice issued for 60 days for having an unlit cigar in his mouth.
- 01/17/26 Incident report and exclusion noticed issued for 60 days to John Doe for refusing to leave property & leash dog. *
- 01/23/26 Incident report and exclusion notice issued for 60 days to John Doe and Jane Doe for blocking staff entrance and approaching staff's car with scissors.

- 01/22/26 Incident report staff found Jane Doe in a locked restroom stall; after confirming she didn't need assistance and advising library was closed, she exited without incident at 8:05pm.
- 01/28/26 Incident report staff members of a local group home called 911 because John Doe appeared to be distressed. Emergency services took John Doe to the hospital. *
- 01/29/26 Incident report for patron for leaving unattended personal belongings in the library. Patron was previously warned against leaving personal items unattended on 01/16/26.

- 01/08/26 Incident report and exclusion notice issued for 60 days to a teen John Doe for disturbing the peace, using offensive language, and engaging in behavior that is threatening. *
- 01/29/26 Incident report and exclusion notice issued for 30 days to a teen John and Jane Doe for causing damage, unhinging the entrance doors, and shouting out loudly in the library.
- 01/31/26 Accident report of juvenile patron hitting his head on the exterior rockface column, paramedics took patron to the hospital. *
