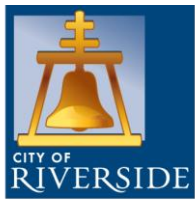
Following discussion and without formal motion, the Commission received and filed the presentation from the City of Riverside Parks, Recreation and Community Services Department about the Friendly Stars Program.

REVIEW THE DRAFT OF THE COMMISSION ON DISABILITIES BROCHURE



UPDATES ON CONFERENCES, SEMINARS AND REGIONAL MEETINGS ATTENDED BY COMMISSIONERS

Commissioner Trimm shared that Riverside Unified School District hosted a Junior and Senior Career Day where a little under 40 different agencies from around the City of Riverside attended and it was a great successful event. Commissioner Trimm also shared that several members from Workforce Development Board and other city members have been hosting job resource fairs for the disabled community that have resulted in a great turn out. Commissioner Trimm mentioned that there is a Career Education Master Plan that members of the community have been invited to and should be a really great event.

Chari Krick spoke on a program offered by Metrolink where students can ride for free. To benefit from this program students will need to register at metrolinktrains.com. If a student is accompanied by another individual, that person will need to pay for a ticket. The student ride program will end the first week of June.

Vice Chair Perkins expressed her appreciation for a Riverside Transit Agency (RTA) employee who was operating a Dial-A-Ride bus #1182 on February 23, 2024. Vice Chair Perkins explained that the bus driver was loading two individuals who were using electric wheelchairs and the driver demonstrated patience. She commends RTA and the Dial-A-Ride for providing great services.
