**NOTICE IS HEREBY GIVEN** that the City of Riverside has prepared its draft amendment of the HUD Annual Action Plan for the program year 2025-2026. The publication of this notice is the beginning of the public review period required under Federal Regulation 21 CFR 91.105 (b)(2). The public review and written comment period will begin on June 12, 2026, and run through July 13, 2026.

At this meeting, the City Council will receive public comment on the 2025-2026 HUD Annual Action Plan that was submitted to the U.S. Department of Housing and Urban Development (HUD) on 05-20-2025.

**BACKGROUND**

The U.S. Department of Housing and Urban Development (HUD) approved the City of Riverside's Five-Year Consolidated Plan in 2020. The Consolidated Plan provides an inventory of existing programs and activities, resources, demographics, unmet needs, and identifies strategies and resources such as Community Development Block Grant funds (CDBG), Home Investment Partnerships Grant (HOME), Housing Opportunities for People with AIDS (HOPWA), and Emergency Solutions Grants (ESG) needed to continue implementing existing programs and activities and to formulate programs and activities needed to address the unmet needs. Since the approval of the Consolidated Plan, it is the Annual Action Plan that incrementally addresses and implements identified programs and activities prepared and submitted to HUD for approval. The Annual Action Plan prepared for 2025-2026 implements the strategy and goals identified in the Consolidated Plan.

Federal Regulation 24 CFR 91.105 requires the City to notify and provide its citizens with an opportunity to comment and provide input on proposed changes to an approved plan. This notice serves this purpose and allows the City to comply with the law. The proposed Substantial Amendment to the approved Plan affected by this Notice will allocate \$1,265,000 to four Parks, Recreation, and Community Services Department (PRSCD) projects:

- Bobby Bonds Skatepark Improvements - \$175,000
- Janet Goeske Senior Center Flooring Replacement - \$250,000
- Bobby Bonds Sippy Woodhead Pool Room Renovations - \$500,000
- Tim Strack Park Lighting and Fitness Installations - \$340,000


