A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AS SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF RIVERSIDE APPROVING A PURCHASE, SALE, AND DEVELOPMENT AGREEMENT WITH R. C. HOBBS COMPANY, INC. FOR THE SALE OF 0.945 ACRES OF SUCCESSOR AGENCY-OWNED VACANT LAND, IDENTIFIED AS ASSESSOR PARCEL NUMBERS 146-231-016, -017, -027, -031, -032, -033, -034, AND -036, LOCATED ON THE SOUTHEAST CORNER OF HOLE AND BUSHNELL AVENUES, RIVERSIDE, CALIFORNIA, FOR THE DEVELOPMENT OF A 33-UNIT, 15% AFFORDABLE MULTI-FAMILY RESIDENTIAL PROJECT IN THE SALE AMOUNT OF \$560,000.

WHEREAS, pursuant to Resolution No. 22322, adopted by the City Council of the City of Riverside on January 10, 2012, the City of Riverside ("City") agreed to serve as the Successor Agency ("Successor Agency") to the former Redevelopment Agency of the City of Riverside ("Redevelopment Agency") commencing upon dissolution of the Redevelopment Agency on February 1, 2012 pursuant to Assembly Bill x1 26 ("AB 26"); and

WHEREAS, Health and Safety Code Section 34177 (i) provides that a successor agency is required to continue to oversee development of properties until the contracted work has been completed or the contractual obligations of the former redevelopment agency can be transferred to other parties; and

WHEREAS, the Successor Agency currently owns 0.945 acres of vacant land located on the southeast corner of Hole and Bushnell Avenues, bearing Assessor's Parcel Numbers 146-231-016, -017, -027, -031, -032, -033, -034, and -036 ("Property"); and

WHEREAS, pursuant to Assembly Bill 1484 and Health and Safety Code Section 34191.5(c)(2), the Successor Agency prepared a Long Range Property Management Plan dated February 25, 2014, for the disposition of the former Redevelopment Agency properties, which included the Property; and

WHEREAS, on March 6, 2014, the Department of Finance approved the Successor Agency Long Range Property Management Plan ("Plan"); and

1 WHEREAS, the Plan sets forth the sale of the Property at fair market value subject to future
2 development on the Property as set forth in Exhibit “A” attached hereto and incorporated herein by
3 reference; and

4 WHEREAS, R. C. Hobbs Company, Inc. submitted a proposal to purchase and develop a multi-
5 family residential project on the Property; and

6 WHEREAS, the Successor Agency desires to sell the Property to R. C. Hobbs Company, Inc.

7 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
8 California, as the Successor Agency to the Redevelopment Agency of the City of Riverside, as follows:

9 Section 1. The above recitals are incorporated herein as if set forth herein in full.

10 Section 2. Pursuant to the Plan, the Successor Agency hereby agrees to convey the
11 Property to R. C. Hobbs Company, Inc.

12 Section 3. It is in the best interest of the Successor Agency to enter into a Purchase, Sale,
13 and Development Agreement with R. C. Hobbs Company, Inc. for the disposition of the Property, for
14 the subsequent development of a 33-unit, 15% affordable multi-family residential project in the sale
15 amount of Five Hundred Sixty Thousand Dollars (\$560,000).

16 Section 3. That the City Manager, or his designee, acting on behalf of the Successor
17 Agency, is authorized to execute the Purchase, Sale, and Development Agreement and any other
18 documents as necessary to carry out the intent of this Resolution.
