ISSUE:

DISCUSSION:

The following Police Department related items were agendized for the City Council as noted below:

March 28, 2023

- (1) MEASURE Z increased spending authority to purchase new and used vehicles for the Police Department in the amount not-to-exceed \$2,563,791.70.
- (2) Adopted an Ordinance of the City of Riverside, California, authorizing an amendment to the Contract between the City of Riverside and the Board of Administration of the California Public Employees' Retirement System for implementation of retirement cost-sharing provision of 5.5 percent of pensionable income for all classic, Tier 1 and Tier 2 Unrepresented Police Management employees, members of Riverside Police Administrators' Association (RPAA) and retirement cost-sharing provision of 4.5 percent of pensionable income for all classic Tier 1 and Tier 2 members of the Riverside Police Officer's Association (RPOA) and Riverside Police Officer's Association Supervisory.

April 4, 2023

- (1) Appropriate \$461,872.30 funding Grants and Special Programs for overtime and maintenance reimbursement in various task forces.

April 11, 2023

- (1) The Board of State and Community Corrections awarded \$245,026.85 to support Riverside Police Department's Employee Wellness Program through 2021-2024.

- (2) MEASURE Z acquired 15 Motorola Enhanced APX 6500 7/800 MHZ Mobile in-car radios, accessories, and three-year service warranty from Motorola Solutions in the amount of \$107,680.39.
- (3) MEASURE Z acquired 15 WatchGuard in-vehicle video systems from Motorola Solutions, Inc. for accessories, software, licensing, and warranty in the amount of \$107,328.00.
- (4) MEASURE Z acquired 25 Panasonic CF-33 Toughbooks and accessories with five-year warranties from Lehr, Anaheim in the amount of \$162,782.48.
