

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AUTHORIZING THE SUBMISSION OF THE
4 APPLICATION FOR, AND ACCEPTANCE OF, THE OUTDOOR EQUITY
5 GRANTS PROGRAM GRANT FUNDS FOR THE FISCAL YEARS 2024-
6 2025 – 2026-2027 OFFERED BY THE CALIFORNIA DEPARTMENT OF
7 PARKS AND RECREATION OFFICE OF GRANTS AND LOCAL
8 SERVICES FOR THE EASTSIDE DISCOVERS NATURE PROGRAM.

9 WHEREAS, the State Department of Parks and Recreation has been delegated the
10 responsibility by the Legislature of the State of California for the administration of the Outdoor
11 Equity Grants Program, setting up necessary procedures governing the application; and

12 WHEREAS, said procedures established by the State Department of Parks and
13 Recreation require the applicant to certify by resolution the approval of the application before
14 submission of said application to the State; and

15 WHEREAS, successful applicants will enter into a contract with the State of California to
16 complete the Outdoor Equity Grants Program for the Eastside Discovers Nature Program.

17 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
18 California, as follows:

19 1. Approves the filing of an application for grant funds for the Eastside Discover
20 Nature Program, for the Fiscal Years 2024-2025 – 2026-2027, in an amount not to exceed Seven
21 Hundred Thousand Dollars (\$700,000.00), and

22 2. Agrees to, and if awarded, does accept the Grant funds in an amount not to exceed
23 Seven Hundred Thousand Dollars (\$700,000.00); and

24 3. Authorize the Chief Financial Officer or designee to record an increase in
25 revenues, and a like expenditure, in an amount not to exceed \$700,000 in Fiscal Years 2024/2025
26 - 2026/2027 Outdoor Equity Grants Program in accounts to be established by the Finance
27 Department in the City's Grants and Restricted Funds Accounts; and

28 4. Certifies that said applicant has or will have available, prior to commencement of
any work on the program included in this application, the sufficient funds to complete the

1 program; and

2 5. Certifies that if the grant is awarded, the applicant has or will have sufficient
3 funds to operate the program as described in the Grant Administration Guide; and

4 6. Certifies that the applicant has reviewed, understands, and agrees to the General
5 Provisions constrained in the contract shown in the Grant Administration Guide; and

6 7. Delegates the authority to the City Manager, or his designee, to conduct all
7 negotiations, sign and submit all documents including, but not limited to applications,
8 agreements, amendments, and payment requests, which may be necessary for the completion of
9 the Grant Scope; and

10 8. Agrees to comply with all applicable federal, state and local laws, ordinances,
11 rules, regulations and guidelines.
