BACKGROUND

1. October 6, 2020 - Council authorized submittal of a \$1,000,000 grant application through the CALSTART "Clean Mobility Voucher Pilot Program" to establish a network of hydrogen fuel cell vehicles
2. Application a partnership with StratosShare and the University of California Riverside's Center for Environmental Research and Technology (UCR CE-CERT).
3. The Grant was formally accepted by City Council on July 6, 2021.

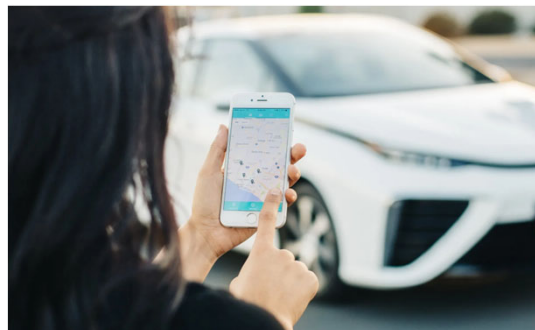

DISCUSSION

RIVERSIDE CLEAN AIR CAR SHARE

1. Up to 21 hydrogen fuel cell vehicles
2. 7 stations - Up to 3 vehicles per location
3. 2 free hours a day for qualified users

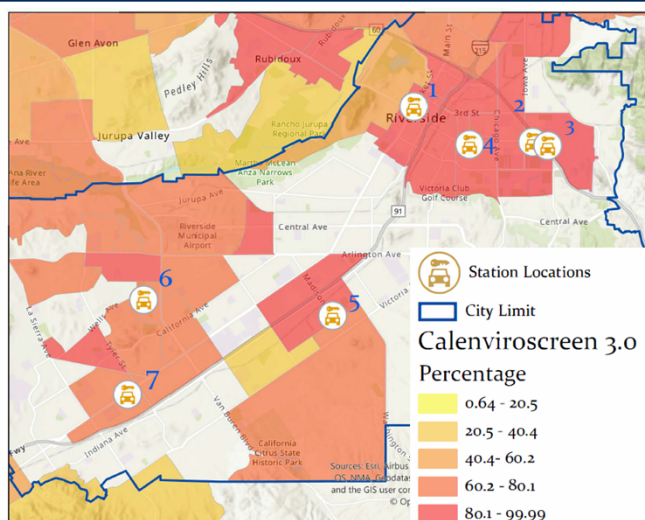
