BOARD OF PUBLIC UTILITIES

DATE: JUNE 10, 2024

SUBJECT: PROFESSIONAL SERVICES AGREEMENT WITH THE GREATER RIVERSIDE CHAMBERS OF COMMERCE FOR SERVICES AND SPONSORSHIPS PROVIDED TO RIVERSIDE PUBLIC UTILITIES, FOR A TERM FROM JUNE 30, 2024, TO JUNE 30, 2026, ANNUAL EXPENDITURE AMOUNT OF \$69,245

ISSUE:

Consider approving the annual expenditure of \$69,245, for Fiscal Years 2024/2025 and 2025/2026 for the Professional Services Agreement with the Greater Riverside Chambers of Commerce for services and sponsorship events for Riverside Public Utilities.

RECOMMENDATION:

That the Board of Public Utilities approve an annual expenditure in an amount not to exceed \$69,245 for Fiscal Years 2024/2025 and 2025/2026 for the Professional Services Agreement with the Greater Riverside Chambers of Commerce for services and sponsorship events for Riverside Public Utilities, including an optional two-year term of the agreement subject to availability of funds.

BOARD ACTIONS:

1. On October 28, 2019, the Board of Public Utilities, approved an expenditure in an amount not to exceed \$68,000 for Fiscal Year 2019/20 to the Greater Riverside Chambers of Commerce (GRCC) and conceptually approved the scope of services for sponsorships and services specifically provided to the Public Utilities Department.
2. On September 13, 2021, the Board of Public Utilities, ratified an expenditure in an amount not to exceed \$39,520 for fiscal year 2020/21 and approved an expenditure in an amount not to exceed \$68,000 for fiscal year 2021/22.
3. On May 13, 2024, the Board of Public Utilities discussed this item, requested additional information, and continued the matter to their June 10, 2024, meeting.

BACKGROUND:

The Greater Riverside Chambers of Commerce (GRCC) has served the City of Riverside (City) and surrounding communities for over 100 years. The organization started in 1900 and took on two (2) important projects, which included bringing a rail line to Riverside and writing a City Charter

later adopted by the City of Riverside board of Trustees in 1907. Collaboration between the City of Riverside and the GRCC began immediately and contracts between the two entities date back at least 50 years. The GRCC was instrumental in convincing the State to establish a Citrus Experiment Station at the base of Mt. Rubidoux and then to gain a larger station near Box Springs Mountain, convincing the Federal government to establish March Field as an aviation training facility in 1918, now known as March Air Reserve Base, helping to establish the Riverside National Cemetery in 1976, working to bring the Sherman Institute and the School for the Deaf to Riverside, establishing University of California, Riverside Liberal Arts College through letters, telephone calls, and trips to Sacramento and Washington D.C.. The GRCC also campaigned for Park Bonds in support of the creation of the 8th Street underpass and for the planning of Riverside's first freeway in the 1940's and 1950's.

In 1934, in the midst of a depression, the GRCC was successful in attracting 30 conventions to the Consolidated Costs for GRCC Services. Through the years, the GRCC has recruited many businesses to Riverside, such as Rohr Aircraft, Bourns, Flexsteel, Ralph's/Food 4 Less, Amtrak Call Center, Nordstrom, Wal-Mart, Hunter Engineering, and the Wall Street Journal. The GRCC has also assisted with the reopening of the Mission Inn Hotel and Spa, the Cal Tower Project, the creation of the Justice Center, and the establishment of Keep Riverside Clean and Beautiful to help improve Riverside's image to the rest of the Country.

The GRCC has established itself as the voice of businesses in Riverside, speaking on behalf of approximately 1,500 member firms and collectively representing 112,000 employees. The GRCC helps local companies grow their business by taking the lead in programs and efforts that help create a strong local economy and make the community a great place to do business. It recognizes that the best interests of the business community are the same as the long-term interests of the community at large and thus supports initiatives that lead Riverside to a prosperous future. As a member-driven organization, the GRCC works daily to provide programs, product services, advocacy and networking designed to give its members a return on their investment.

Through the GRCC's work, they have created a micro culture of networking and relationship development that leads to an environment of inclusiveness and servitude. They provide numerous opportunities for members and others to increase their contact base via various meetings, networking events and committees and serve as an advocate for business in the greater Riverside area. Often, a business will consider the GRCC the first "call" when it comes to expansion and referrals of ancillary businesses to the community. In addition, through the GRCC's active member call program, the GRCC is able to connect to all 1,144-GRCC members annually to conduct a business check-up, which often leads to referrals to City Departments.

RPU's partnership with the GRCC

To encourage load growth and maintain current load, RPU works with the GRCC to attract and retain businesses. RPU delivers electricity to customers through distribution and transmission facilities. These facilities represent long-term capital investment whose dollars are spread amongst all customers and recovered over periods in the range of 20 to 30 years. Energy is produced and/or obtained from generation Consolidated Costs for GRCC Services and facilities through long-term contracts to meet base load needs, with cyclical and peaking needs obtained through short-term contracts, internal generation or on the open market. The purchases through short-term contracts and the open market represent the marginal cost of power for increased load requirements. RPU has a number of fixed costs which must be paid regardless of customer demand or load. Additional revenue generated by expanded load (new customers) will reduce the

costs to existing customers, as the fixed costs will be allocated over a larger group of customers. Below is a brief description of RPU's fixed costs:

Distribution and Transmission Costs: Cost recovery for distribution and transmission facilities are built into electric rates based upon the number and load of existing customers and include a limited growth factor. Cost recovery for these fixed costs is spread over several decades. Over a longer, several-year period, an increase of new customer load would help reduce the overall distribution and transmission costs for all customers.

Generation Costs: Energy costs for a significant new load represent RPU's marginal cost of power, a variable cost. At a minimum, any new customer should be charged for this marginal cost to ensure RPU receives revenues to cover new costs.

In 2001, Riverside Public Utilities (RPU) entered into a partnership whereby the GRCC would conduct certain targeted economic development activities in exchange for a set dollar annual commitment of funds. Since 2001, the amount varied slightly each year. The funds were paid from RPU's Public Utilities – Customer Engagement (Community Support Outreach and Education). The activities were meant to 1) target businesses for attraction that provided a significant electrical load growth that could benefit from RPU's Economic Development rate, 2) target businesses for attraction that could benefit from reduced electric and water rates compared to their current jurisdiction and 3) help facilitate meetings with current commercial ratepayers that were considering facilities' expansion.

Prior to 2019, the services provided by, and the sponsorships and memberships paid to the GRCC were done at the Department level and did not generally require Riverside Public Utilities Board or City Council approval.

In Fiscal Year 2019/2020, RPU opted to attend certain GRCC events based on the number of attendees and the expected demographics of the event, many of which were recognized at a sponsorship level that was higher than the amount paid. RPU finds GRCC events a great opportunity to engage with commercial business customers. GRCC sponsored events included the following:

1. Business Expo
2. Mega Mixer
3. KRCB Recognition Luncheon
4. Good Morning Riverside Sponsor
5. Legislative Summit
6. Mayor's State of the City
7. Inaugural Ball
8. Athena Luncheon
9. Leadership Riverside Lunch

In October 2019, through an effort to provide greater public transparency and clarification, all services, sponsorships, memberships, and other benefits were consolidated and itemized into a singular, comprehensive Professional Services Agreement which included a detailed scope of services and event sponsorships. The agreement included services and events previously budgeted for and attended.

The services included with 2019 agreement provide important benefits to the City such as retention and expansion of local businesses; attraction and expansion of businesses from desired

industries; support and training in key areas for businesses and entrepreneurs; increased awareness of local programs and resources that support businesses; State of the City; Festival of Lights; and corporate memberships with the GRCC.

DISCUSSION:

The Professional Services Agreement with GRCC for Retention and Expansion of Local Businesses; Attraction and Expansion of Business from Desired Industries; Support and Training in Key Areas for Businesses and Entrepreneurs; Increased Awareness of Local Programs and Resources that Support Business; and State of the City expires on June 30, 2024.

City and RPU staff have been pleased with the partnership and collaboration afforded through the GRCC.

The Scope of Services for the 2024 Professional Services Agreement includes, but will not be limited to, the following services and benefits:

1. Retention and expansion of local businesses

The GRCC will encourage a dialogue between businesses and RPU to share priorities, concerns, plans for future growth and opportunities, gain, and disseminate advance insight when businesses are considering potential changes or evaluating new directions, and enhance positive working relationships between businesses and the City, in order to retain current businesses.

2. Attraction and expansion of businesses from desired industries

The GRCC will continue Riverside's reputation as a City and community that welcomes business investment and growth, enhanced by our partnerships and collaborations between private and public stakeholders, and increase awareness of Riverside's potential and the many resources, talents, and treasures available to businesses and residents.

3. Support and training in key areas for businesses and entrepreneurs

The GRCC will provide training and resources to develop successful and sustainable businesses, including energy efficiency and conservation.

4. Increased awareness of local programs and resources that support business

The GRCC will provide multiple avenues and platforms to share local resources, economic development updates, and other information in a comprehensive and cohesive manner so that individuals looking to invest in, start, retain, or expand a business in Riverside can easily and quickly find beneficial information.

5. State of the City

The GRCC will facilitate a "State of the City" consistent with section 405 of the Riverside City Charter, to allow the Mayor of Riverside to present the Mayor's programs, objectives, and priorities.

6. Schedule of Sponsorships

The following sponsorships by the City will result in completion of Task 1 by the GRCC and as included in the scope of services, inclusive of a cost comparison from the prior contract:

The Festival of Lights sponsorship is a pass through to the Mission Inn Hotel and Spa for the costs associated with the annual switch on ceremony attended by over 60,000. RPU receives recognition on branded event materials and outreach including flyers and social media. The Mission Inn hotel and Spa's Festival of Lights is a free event, running from November to January each year, attracting over 700,000 visitors this past year, that promotes the City of Riverside as a desirable place to live, visit and do business. The Festival of Lights resulted in an economic impact of \$154 million to the City, according to a report prepared by SMRI (February 2024).

The City is consolidating all GRCC services, sponsorships, memberships, and other benefits across all City Departments into a single agreement for a total amount not to exceed \$98,775 for Fiscal Years 2024/2025 and 2025/2026, which includes an annual \$69,245 expenditure from RPU. The agreement includes services typically budgeted and received in the current and previous years and is not intended to add new GRCC services at this time. As with the past Agreement, the intent remains to provide public clarification and transparency for the Citywide partnership with the GRCC. The agreement, including the scope of services, schedule of sponsorships and associated costs, will be reviewed and evaluated every two years during budget preparation and brought before the Board and City Council with the budget adoption.

At the May 13, 2024, Board of Public Utilities meeting, the Board requested additional information on several items and that staff bring this item back at their June 10, 2024, Board Meeting. The additional information requested includes:

Why Does RPU Participate in the GRCC?

RPU's partnership with the GRCC allows the RPU Board members, Executive team, and staff access to key business leaders at business-focused events similar to outreach programs designed to reach residential customers. Through the attendance at GRCC events, RPU saves substantial expense by avoiding the cost of hosting and facilitating similar events and additionally benefits from GRCC's resources and business community connections. In addition, GRCC excels at convening business leader from small and micro-businesses to large business, across a wide array of sectors, and all GRCC events are well attended.

RPU takes advantage of the GRCC events to collaborate with and receive feedback from the business community on their current and future needs, RPU programs, to highlight the economic benefit businesses receive as RPU's commercial ratepayers. Some conversations include retention discussions with business leaders that may be considering leaving Riverside, conversations with businesses that are interested in expanding their business footprint in Riverside, assisting a potential new commercial customer seeking information on the estimated reduction to operating costs just be relocating to RPU's service territory or participating in efforts to attract new businesses to the City.

These conversations are essential to the City and the Utility's continued success and future growth. Although measuring the exact economic return for these interactions is difficult to calculate, the cumulative relationship building and conversation with RPU and the business community via the GRCC helps retain or contributes to additional sales for RPU.

Metrics

The Economic Development Services included in the GRCC contract with RPU directly support RPU's objective to encourage load growth and maintain current load with businesses. The following section details the 2022/2023 deliverables per task as reported by the GRCC.

Task 1 Description and Deliverables for 2022/2023

Retention and expansion of local businesses

Deliverables

Commit to the partnership and collaboration between the Chamber, the City, the County, the University of California, Riverside, California Baptist University, La Sierra University, and Riverside Community College District to identify and attract key assets and industries to relocate or expand to Riverside. Pivoting from the successful collaboration to bring the California Air Resources Board emissions testing facility to Riverside, work with these partners to actively focus on desired industries and capitalize on specific opportunities.

Plan, prepare and execute litter cleanup for The Mission Inn & Spa Festival of Lights Switch-On Ceremony, which occurs on the day after Thanksgiving.

On November 18, 2023, Keep Riverside Clean & Beautiful (KRCB) mobilized volunteers for the Switch-On Ceremony of the Festival of Lights. The community participates in beautification efforts by removing litter and debris from the festival footprint from 4:00 to 12:00 PM, as well as walking the festival footprint to distribute event programs to the public.

At the end of evening, when the vendors have closed, Chamber and KRCB staff plus Teen Challenge volunteers mobilize one final time to collect over 100 trash bins that were placed throughout the four-block festival footprint the morning of the event. These bins contain the waste from the event and are stored safely on City property at the close of the evening for the designated trash haulers collection early the next day. This procedure ensures the beautification and cleanliness for thousands of festival goers for the next night.
