The City Manager's Office provides an annual update to City Council regarding the status of the City's external funding operations.





DISCUSSION

In CY 2024 the City received approximately \$54,980,752 in new grant funds from various funding types including competitive, entitlements, appropriations, and earmarks. This breaks down to:

- \$42,686,353 Competitive Awards;
- \$3,664,250 Earmarks/Appropriations; and
- \$8,630,149 Entitlements.

DISCUSSION

Riverside submitted 65 competitive grant applications with a combined value of \$70,203,978.

- -The City received 50 competitive grant awards with a combined value of \$42,686,353.
- -The City's grant completion rate (applications versus awards) was very high at 77%.

DISCUSSION

Comparisons to the municipal General Fund:

- Estimated General fund (FY 2023/24) approximately \$367 million
 - Competitive grant work alone would be <u>12% of the General</u> fund.
 - All grant work (competitive, earmark, & entitlement) would be 14% of the estimated General Fund total.

Grant writing makes a substantial additional impact to the funded operations of municipal programs and projects.

DISCUSSION

Grants impacted the lives of Riverside residents:

- Provided <u>59</u> formally homeless individuals with prevention svc.;
- Offered swim lessons or passes to 12,445 residents;
- Assisted <u>195</u> low-income renters with emergency assistance;
- Added 16.2 miles of bike lanes to improve community health;
- Developed <u>182</u> affordable housing units.

Innovation – Funding provides the City with the ability to create an innovative program for building capacity



Sustainability and Resiliency – Builds capacity to allow more departments to apply for grants, and compete for funding that allows the City to adaptively address resident needs.
