## **Background**

- To ensure the work of Boards and Commissions align with the City Charter and Envision Riverside 2025 Strategic Plan, the City Manager's Office requested each Board or Commission to develop an Annual Workplan.
- Each Workplan will be taken to the respective City Council Standing Committee for review and approval with the Workplans earmarked to begin in March 2025 and conclude in February 2026.
- Resolution 23976 identifies the following seven boards and commissions under the purview of the Safety, Wellness, and Youth Committee: Commission of the Deaf, Community Police Review Commission, Board of Library Trustees, Commission on Aging, Commission on Disabilities, Museum of Riverside Board, and the Park and Recreation Commission.

- The workplan outlined 5 main goals with 7 specific items to focus on for the 2024 Calendar Year.
