





- **To lease for \$702 monthly.**



# FAA FSDO ROOF REPAIRS BID AWARD

- On January 16, 2024, City Council approved a supplemental appropriation in the General Fund of \$1,000,000 from the Infrastructure Reserve for an interfund transfer to the Airport Fund and record supplemental appropriations in the same amount in Airport Capital Projects expenditure account for FAA FSDO building remedial repairs.
- 7 Bids responsive received.
- Award Bid No. 8043 to Roy O. Huffman Roof Company of Riverside, California for the removal and replacement of the roof at the Federal Aviation Administration building located at 6961 Flight Road, in the amount of \$394,292, and authorize 15% change order authority up to \$59,143 for a total not to exceed amount of \$453,435.
