# FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT

THIS FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("First Amendment") is made and entered into this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2025, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and HOLT ARCHITECTS, INC., a California corporation, doing business as HOLT ARCHITECTURE ("Consultant"), with respect to the following:

### **RECITALS**

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated March 14, 2024, in the amount of Ninety-Nine Thousand Dollars (\$99,000.00) for Architectural Design for the new City of Riverside Police Headquarters (RFP No. 2288) ("Agreement"); and

WHEREAS, the Agreement expired on November 1, 2024; and

WHEREAS, the City and Consultant have agreed to extend the term of the Agreement through March 1, 2028, to add additional services and additional Compensation in the amount of not to exceed Three Million Three Hundred Thirty-One Thousand Nine Hundred Sixteen Dollars (\$3,331,916.00) for the extended term of the Agreement, for a new Compensation amount not to exceed Three Million Four Hundred Thirty Thousand Nine Hundred Sixteen Dollars (\$3,430.916.00).

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Exhibit "A" of the Agreement, Scope of Services, is hereby amended by adding the additional services set forth in Exhibit "A-1," attached hereto and incorporated herein by reference.
- 2. Section 2, Term, is hereby amended to extend the term of the Agreement through March 1, 2028.
- 3. Section 3, Compensation/Payment, is hereby amended to increase the Compensation in the amount of not to exceed Three Million Three Hundred Thirty-One Thousand Nine Hundred Sixteen Dollars (\$3,331,916.00) for the extended term of the Agreement, for a new Compensation amount not to exceed Three Million Four Hundred Thirty Thousand Nine Hundred Sixteen Dollars (\$3,430.916).
- 4. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.

Hello Robert:

On behalf of Holt Architecture, I am pleased to provide you with this Proposal for Professional Services.

### A. Base Scope Program:

- 1. Not Essential Service Administration only.
- 2. Building:
  - i. Size: 40,000 SF maximum.
  - ii. 2-Story above grade, 1-story below
  - iii. Covered rooftop occupied area
- 3. Parking:
  - i. 6 space below-grade Sallyport.
  - ii. 50 secured on-site staff parking spaces.

### B. Assumptions / Services Included in Base Services:

- 1. Photovoltaic System (rooftop or carport)
- 2. Technology System Design
- 3. T-24 Commissioning
- 4. Traditional building foundations have been assumed in the Base Services. If specialty soil stabilization efforts and/or specialty foundation designs are required as identified in the Geotechnical Report, additional services may be necessary.

    - Geotechnical / Percolation (Infiltration).

- Records of Utility services.
- Water Flow Tests (for Fire Sprinkler).
- Accessibility (Path of travel to site or if existing building is to remain).
