Public hearing was called to establish Community Facilities District No. 2025-2 Sagecrest, authorizing the levy of a special tax to pay the costs of providing public safety and maintenance services. No one spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Mill and seconded by Councilmember Robillard to adopt a Resolution establishing Community Facilities District CFD No. 2025-2 Sagecrest, authorizing a levy of special taxes to pay the costs of providing public safety and maintenance services within the District, and calling an election therein. The motion carried unanimously with Councilmember Conder absent.

EVIDENCE TRUST FUNDS - FUND TRANSFER - SUPPLEMENTAL APPROPRIATION

Following discussion, it was moved by Councilmember Cervantes and seconded by Councilmember Robillard to (1) receive the cost of service and rate design study results and recommendations for water treatment facilities to meet Per-and-Polyfluoroalkyl Substance (PFAS) regulations; (2) approve establishing a Water Treatment Designated Reserve in Water Utility Fund to set aside proceeds received from PFAS settlements for capital costs of water treatment plants; (3) recommend staff offset the capital cost of the water Treatment Facility 1, utilizing an Ion Exchange (IX) WTP, to meet PFAS regulations
