ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, LEVYING SPECIAL TAXES TO BE COLLECTED DURING FISCAL YEAR 2025-2026 FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON AND ADMINISTRATIVE EXPENSES WITH RESPECT TO THE BONDS OF COMMUNITY FACILITIES DISTRICT NO. 2004-1 (GALLERIA AT TYLER) OF THE CITY OF RIVERSIDE, CALIFORNIA, AND DECLARING THIS ORDINANCE TO BE EFFECTIVE UPON ADOPTION.

The City Council of the City of Riverside, California, does ordain as follows:

<u>Section 1:</u> Findings. It is necessary that the City Council of the City of Riverside levy special taxes pursuant to Sections 53340 and 53358 of the Government Code on parcels of taxable real property within Community Facilities District No. 2004-1 of the City of Riverside, (the "District") for the payment of the principal of and interest on the bonds of the District, and for the payment of administrative expenses incurred in connection with the levy and collection of said special taxes and the payment of such principal and interest.

- <u>Section 2:</u> Levy of Special Taxes. Special taxes shall be and hereby are levied for the fiscal year 2025-2026 on all parcels of real property within the District which are subject to taxation, which are identified in Exhibit "A" attached hereto, and in the amount set forth for each such parcel in said Exhibit "A." Pursuant to said Sections 53340 and 53358, such special taxes for Fund 68-2725 shall be collected in the same manner as ordinary *ad valorem* property taxes are collected and shall be subject to the same penalties and the same procedure, sale, and lien priority in case of delinquency as is provided for *ad valorem* taxes.
- Section 3: Transmittal to County. The City Clerk shall upon adoption of this ordinance
 cause a copy to be transmitted to the County Auditor of the County of Riverside together with a
 request that the special taxes as levied hereby be collected on the tax bills for the parcels
 identified in Exhibit "A" hereto, along with the ordinary *ad valorem* property taxes to be levied
 on and collected from the owners of said parcels.
- <u>Section 4</u>: <u>Publication and Effective Date</u>. The City Clerk shall certify to the adoption of
 this ordinance and cause publication once in a newspaper of general circulation in accordance
 with Section 414 of the Charter of the City of Riverside. This is an ordinance fixing the rate of
