

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, ADOPTING THE 2025 URBAN WATER MANAGEMENT PLAN
4 PREPARED BY THE CITY OF RIVERSIDE'S PUBLIC UTILITIES
5 DEPARTMENT.

6 WHEREAS, the California Urban Water Management Planning Act (Water Code sections
7 10610 et seq.) mandates that every supplier providing water for municipal purposes to more than 3,000
8 customers or supplying more than 3,000 acre-feet of water annually to prepare an Urban Water
9 Management Plan, the primary objective of which is to plan for the conservation and efficient use of
10 water; and

11 WHEREAS, the City of Riverside ("City"), through its Public Utilities Department, is an urban
12 supplier of water providing water to more than 3000 customers and supplying more than 3,000 acre-
13 feet of water annually; and

14 WHEREAS, under state law, the City is required to periodically review the plan at least once
15 every five years, and make any amendments or changes to its plan which are indicated by the review;
16 and

17 WHEREAS, the plan must be adopted after public review and hearing, and filed with the
18 California Department of Water Resources within thirty days of adoption; and

19 WHEREAS, the City has therefore prepared and circulated for public review a draft 2025
20 Urban Water Management Plan, and a properly noticed public hearing regarding said plan was held
21 by the Board of Public Utilities on June 8, 2026; and

22 WHEREAS, the City of Riverside has prepared and shall file said plan with the California
23 Department of Water Resources.

24 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
25 California, based upon the foregoing facts, the staff report and other evidence submitted by staff, as
26 follows:

27 Section 1: The 2025 Urban Water Management Plan attached hereto as Exhibit A is hereby
28 adopted and ordered filed with the City Clerk.

1 Section 2: The 2025 Urban Water Management Plan shall be filed with the California
2 Department of Water Resources within thirty days of this adoption.

3 Section 3: This resolution is exempt from CEQA pursuant to State CEQA Guidelines section
4 15282(v), which exempts the preparation and adoption of Urban Water Management Plans. In
5 addition, this action is exempt under CEQA Guidelines section 15061(b)(3), as it can be seen with
6 certainty that there is no possibility that the adoption of the Plan may have a significant effect on the
7 environment.

8 Section 4: The City Manager or designee is authorized to make minor, non-substantive
9 corrections to the Plan as necessary to ensure compliance with state law or Department of Water
10 Resources requirements.

11 Section 5: This resolution shall take effect immediately.
