2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE
3 CALIFORNIA, AUTHORIZING THE CITY MANAGER, OR HIS
4 DESIGNEE, TO EXECUTE A STANDARD AGREEMENT CONTRACT
5 WITH THE STATE OF CALIFORNIA DEPARTMENT OF ALCOHOLIC
6 BEVERAGE CONTROL FOR THE ALCOHOL POLICING PARTNERSHIP
PROGRAM (APP) AND ACCEPT A GRANT AWARD IN THE AMOUNT
OF \$90,000.00 TO INCREASE ENFORCEMENT ACTIVITY AND
COMBAT ALCOHOL-RELATED CRIMES IN RELATION TO
ALCOHOLIC BEVERAGE CONTROL VIOLATIONS FOR THE PERIOD
OF JULY 1, 2025, THROUGH JUNE 30, 2026.

7 WHEREAS, the City of Riverside, by and through the Riverside Police Department (“RPD”),
8 desires to increase enforcement activity and combat alcohol-related crimes in relation to alcoholic
9 beverage control in collaboration with the Department of Alcoholic Beverage Control investigators,
10 to be funded in part from funds in the amount of Ninety Thousand Dollars (\$90,000.00), made
11 available through the Alcohol Policing Partnership Program (APP) administered by the Department
12 of Alcoholic Beverage Control (“ABC”).

13 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
14 California, as follows:

15 Section 1: That the City Manager of the City of Riverside, or his designee, is authorized to
16 execute on behalf of the City Council the Standard Agreement contract (“Contract”) which is hereto
17 attached as Attachment “A”, and any extensions or amendments thereof and any subsequent contract
18 with the State of California in relation thereto.

19 Section 2: Any liability arising out of the performance of the Contract, including civil court
20 actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The
21 State of California and ABC disclaim responsibility for any such liability.

22 Section 3: That grant funds in the amount of Ninety Thousand Dollars (\$90,000.00), be
23 received hereunder, shall not be used to supplant expenditures controlled by this body.

24 Section 4: This award shall not be subject to local hiring freezes.
