SUBJECT: FIFTH AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES

AGREEMENT FOR ENVIRONMENTAL COMPLIANCE TRACKING DATABASE SOFTWARE FOR THE RIVERSIDE WATER QUALITY CONTROL PLANT WITH ENFOTECH & CONSULTING, INC., BRUNSWICK, NEW JERSEY, TO EXTEND THE CONTRACT TERM THROUGH JUNE 30, 2026, IN THE AMOUNT OF \$46,746.30, FOR A TOTAL NOT TO EXCEED AMOUNT OF \$610,306.30 FOR

THE REMAINING TERM OF THE AGREEMENT

## **ISSUE:**

Approve the Fifth Amendment to the Professional Consultant Services Agreement for Environmental Compliance Tracking Database Software for the Riverside Water Quality Control Plant with Enfotech & Consulting, Inc., of Brunswick, New Jersey, to extend the contract term through June 30, 2026 and increase compensation in the amount of \$46,746.30, for a total not to exceed amount of \$610,306.30 for the remaining term of the Agreement.

## **RECOMMENDATIONS:**

That the City Council:

- Approve the Fifth Amendment to Professional Consultant Services Agreement for Environmental Compliance Tracking Database Software for the Riverside Water Quality Control Plant with Enfotech & Consulting, Inc., of Brunswick, New Jersey, to extend the contract term through June 30, 2026 and increase compensation in the amount of \$46,746.30, for a total not to exceed amount of \$610,306.30 for the remaining term of the agreement; and
- 2. Authorize the City Manager, or designee, to execute the Fifth Amendment to the Professional Consultant Services Agreement, including making minor and non-substantive changes.

# **BACKGROUND**:

The Public Works Department, Wastewater Division, is responsible for the collection, conveyance, and treatment of wastewater generated within the City of Riverside and the communities of Edgemont, Highgrove, Jurupa, Rubidoux, and the unincorporated community of Highgrove. Wastewater is conveyed to the Riverside Water Quality Control Plant (WQCP) through more than 800 miles of sewer lines throughout the City. Wastewater is treated and disinfected at the WQCP so that it can be reused for irrigation or discharged to the Santa Ana River in accordance with federal, state, and local regulations.

The City Council has considered and approved amendments to the Agreement for Environmental Compliance Tracking Database Software with EnfoTech & Consulting, Inc. since the iPACS database was selected in 2012 under RFP No. 1340. Table 1 provides a summary of related City Council actions.

### **DISCUSSION**:

The Public Works Department is requesting to amend the current agreement with EnfoTech & Consulting, Inc. in the amount of \$46,746.30 for a total contract amount not to exceed \$610,306.30 and extend the service period through June 30,2026.

The proposed amendment will further assist the Environmental Compliance Section in managing compliance-related documents (plan check approvals, permit issuance, sampling analyses, Fats, Oil and Grease program, inspections, photographs, etc.) and expedite its business processes.

Purchasing Resolution 24101, Article Seven: Acquisition of Services, Section 702 Exceptions states "Competitive Procurement through the Informal Procurement and Formal Procurement process shall not be required in any of the following circumstances...(u) When the Procurement is for the renewal of maintenance, license(s), support, or a similar need for existing technology systems, including hardware, and the items are procured from a vendor/reseller that was originally selected based on the City's procurement standards, provided that 1) the vendor has been used consecutively since then and 2) if there are any non-substantive changes to the procurement, the Manager is satisfied that the best price, terms and conditions have been negotiated."

The Purchasing Manager concurs that the recommended actions comply with Purchasing Resolution 24101, Section 702.

#### **STRATEGIC PLAN ALIGNMENT:**

- 4. **Innovation** This effort expands the use of technology to help streamline processes and ensure efficiency.
- 5. **Sustainability & Resiliency** Proper operation of the Environmental Compliance division contributes to the sustainability of the City's and region's local water resources and environment.

#### FISCAL IMPACT:
