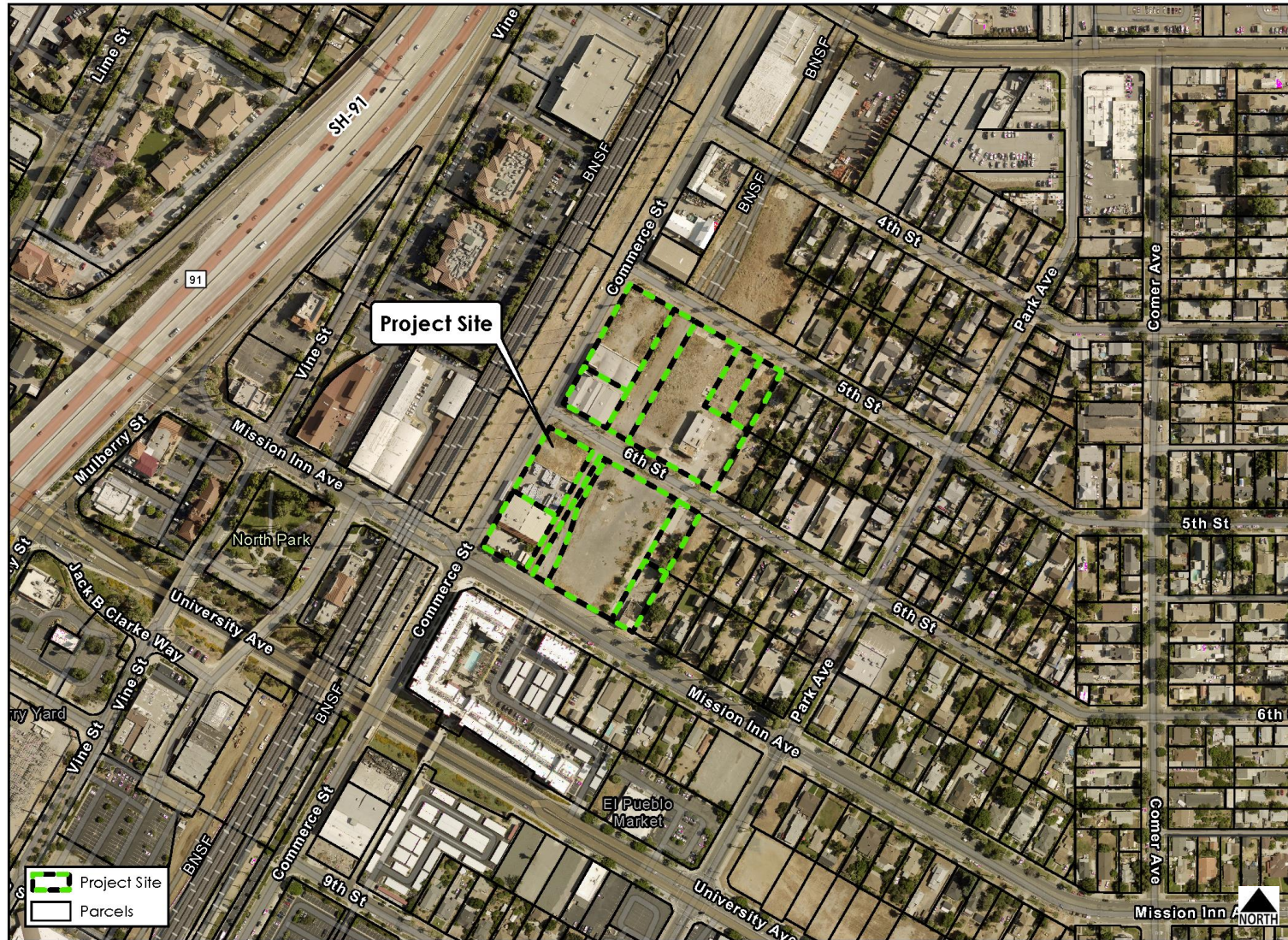

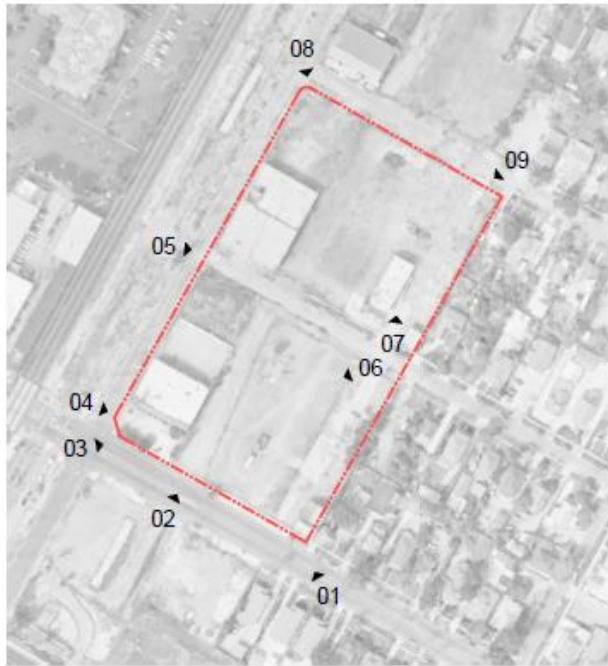

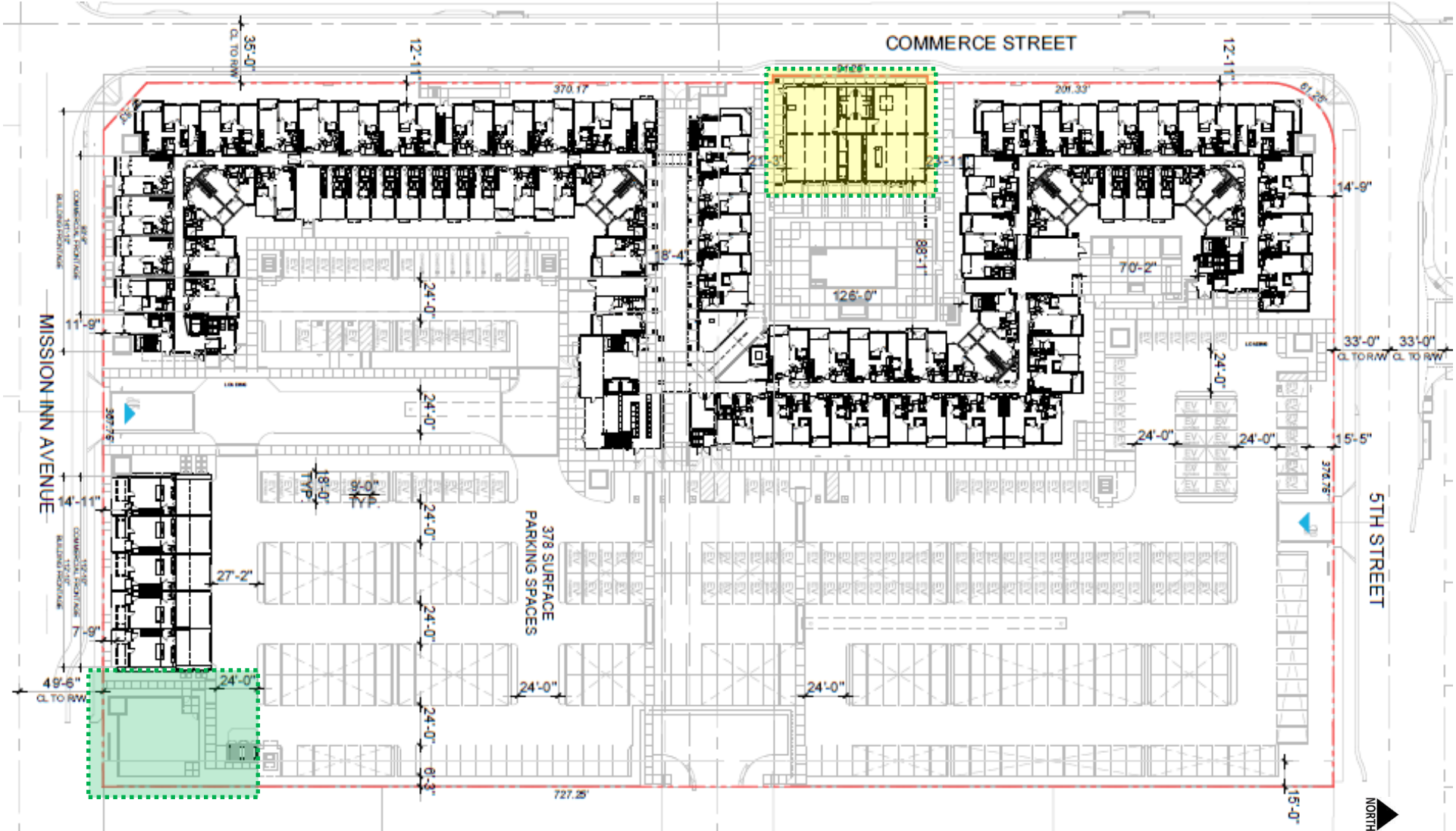

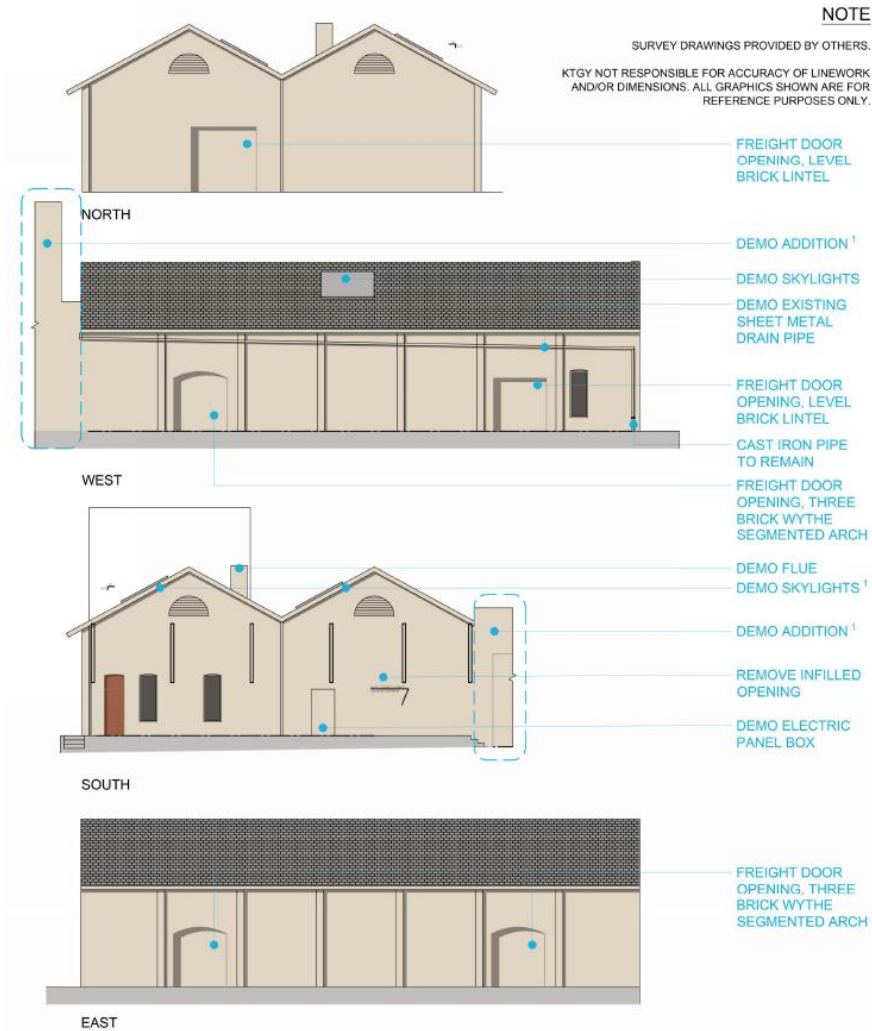

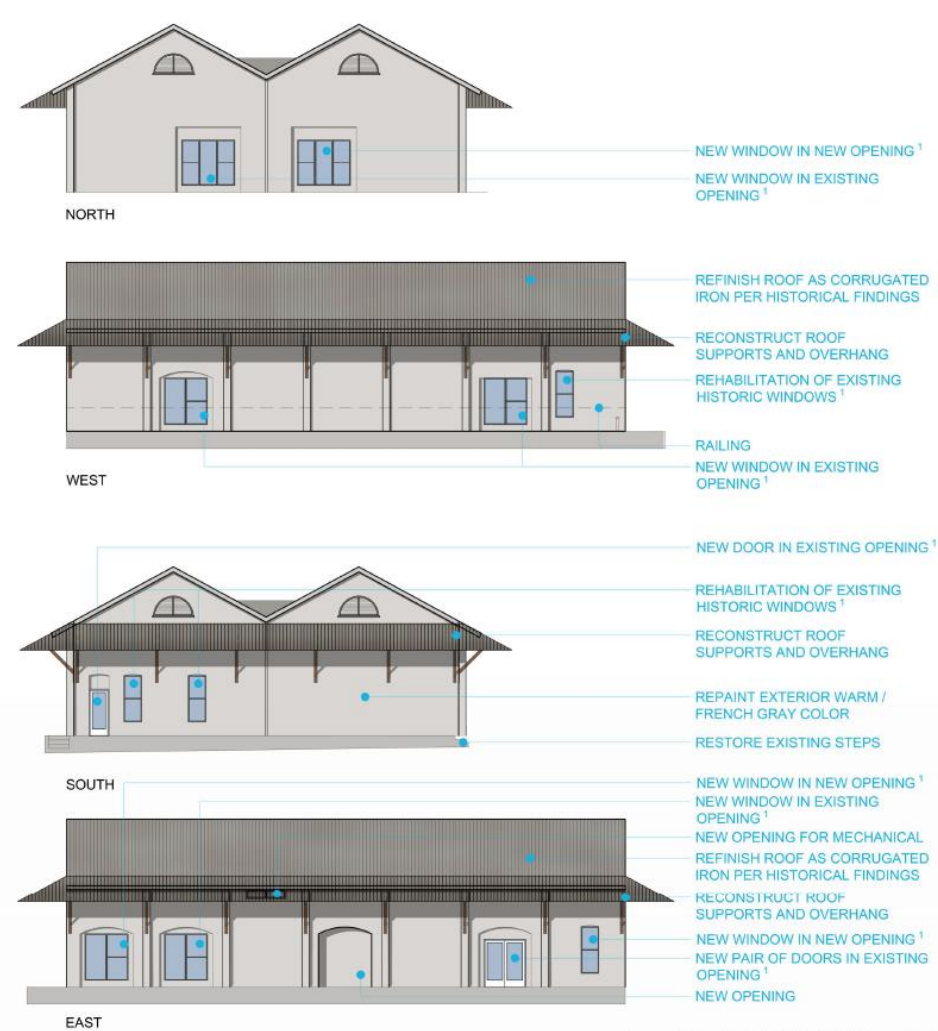

RECOMMENDATION

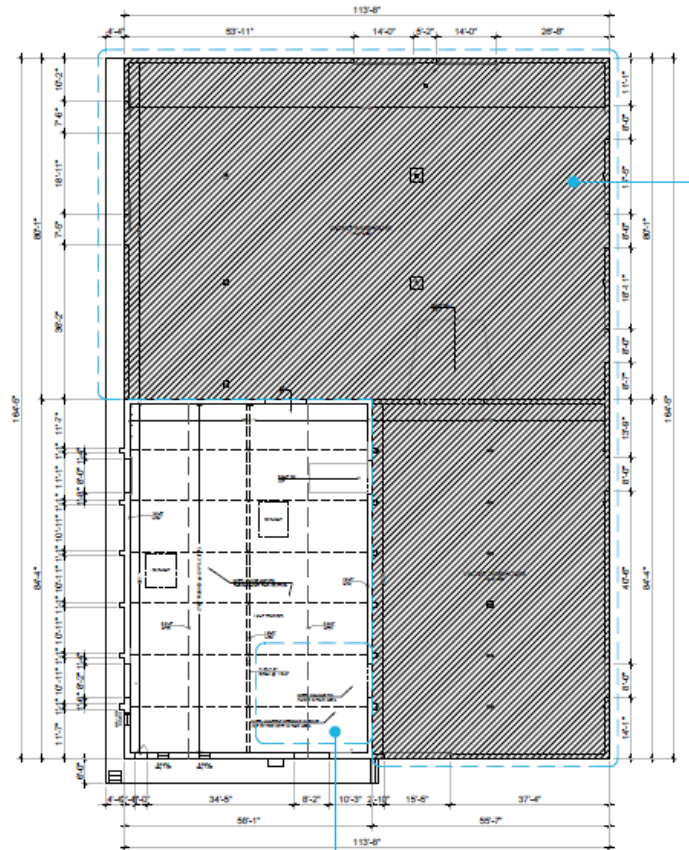
Staff recommends that the Cultural Heritage Board :

- 1. REVIEW and PROVIDE COMMENT UPON** the Cultural Resources analysis in the Mitigated Negative Declaration, and **RECOMMEND** that the City Council **DETERMINE** that Planning Case PR-2023-001469 will not have a significant effect on Cultural Resources so it may **ADOPT** the Mitigated Negative Declaration (Exhibit 3) and **ADOPT** the Mitigation Monitoring and Reporting Program (MMRP); and
- 2. Recommend APPROVAL** Planning Case DP-2025-00463 (Certificate of Appropriateness), based on the facts for findings outlined and summarized in the staff report, and subject to the recommended conditions of approval (Exhibit 1).

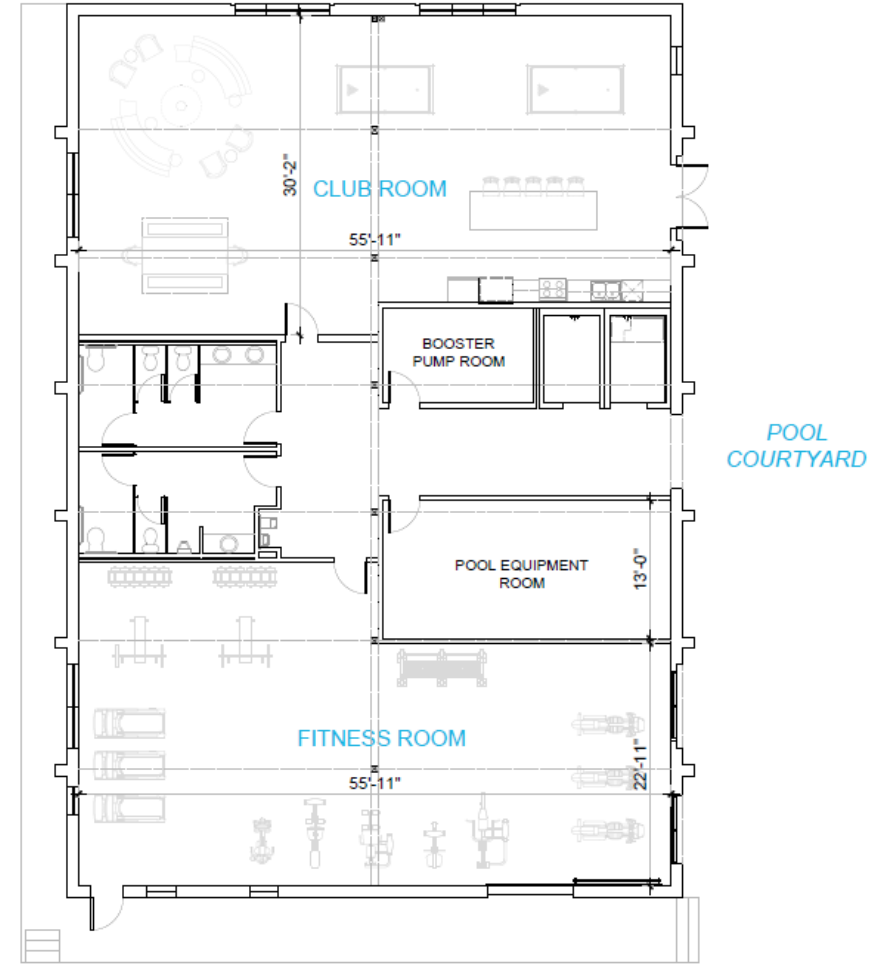

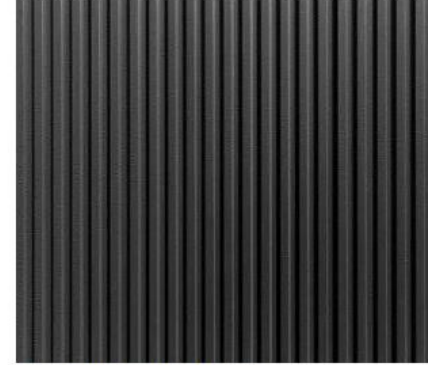

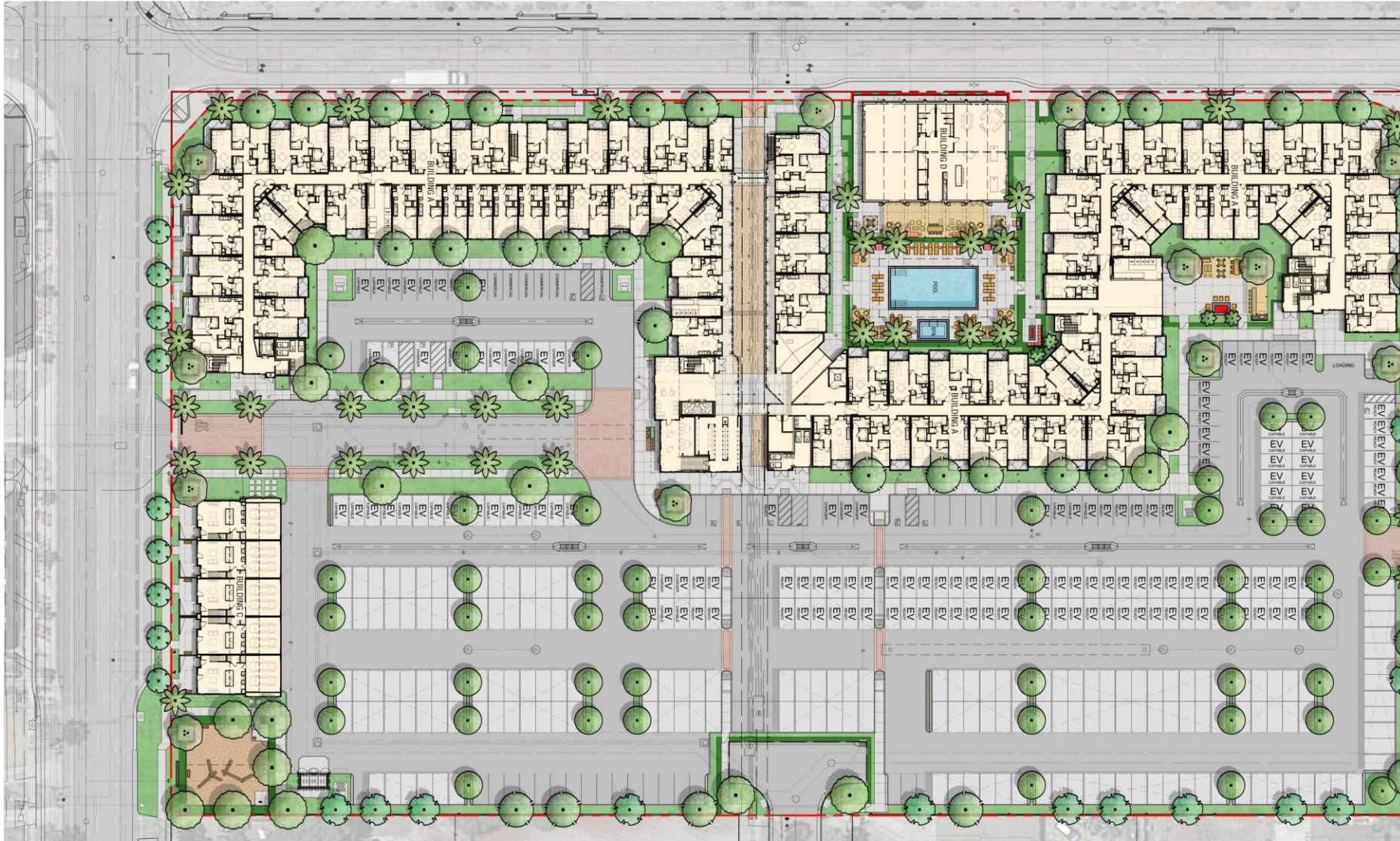
