2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE (“CITY”), CALIFORNIA, AUTHORIZING THE
4 SUBMISSION OF APPLICATION AND ACCEPTANCE OF
5 GRANT AWARD FROM THE U.S. DEPARTMENT OF
6 HOMELAND SECURITY THROUGH THE CALIFORNIA
7 GOVERNOR’S OFFICE OF EMERGENCY SERVICES FOR THE
8 FISCAL YEAR 2022-2023 EMERGENCY MANAGEMENT
9 PERFORMANCE GRANT PROGRAM AND AUTHORIZING THE
10 EXECUTION OF ALL REQUIRED DOCUMENTS BY THE CITY
11 MANAGER, OR HIS DESIGNEE; AND AMENDING THE
12 BUDGET FOR FISCAL YEAR 2022-2023 ACCORDINGLY.

13 WHEREAS, the U.S. Department of Homeland Security (the “Grantor”) has been delegated
14 authority to award federal financial assistance for the Fiscal Year 2022-2023 Emergency
15 Management Performance Grant Program; and

16 WHEREAS, said federal funds have been sub-granted to the California Governor’s Office of
17 Emergency Services (“CalOES”); and

18 WHEREAS, the County of Riverside is the designated Operational Area to which CalOES
19 grant funds are awarded and distributed; and

20 WHEREAS, the City desires to apply for and upon grant award, accept the grant award from
21 the Department of Homeland Security in the amount of Sixty-Two Thousand Seven Hundred
22 Eighteen Dollars (\$62,718); and

23 WHEREAS, the City Council desires to amend the annual budget of the City to reflect and
24 incorporate the grant so awarded to the City, and to increase the annual appropriations and
25 expenditures in the appropriate City program to reflect such award.

26 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
27 California, as follows:

28 Section 1: The City Manager, or his designee, are hereby authorized to submit a grant
application for and on behalf of the City of Riverside, through the County of Riverside, and is
hereby authorized to execute all actions necessary for the purpose of obtaining federal financial
assistance provided by the United States Department of Homeland Security and sub-granted through
the State of California, including any extensions and amendments thereof.
