

This unit has been anchored to the surface with 15 T- anchors and has been tested by our technician, Mr. Gary Frederick, to resist at least an uplift force of 5000 pounds on one anchor point. To assure the strongest possible anchoring, the remaining anchors are not disturbed by an uplift test and are assumed to resist forces in accordance with our engineering standards. This anchoring system will exceed installation wind loading requirements with the doors closed. Port-A-Port assumes no liability for storm damage and other acts of God.
