ORDINANCE NO. 1 2 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 2.08.020 OF THE RIVERSIDE MUNICIPAL 3 CODE REGARDING THE **ADMINISTRATIVE** DEPARTMENTS OF THE CITY. 4 5 The City Council of the City of Riverside does ordain as follows: 6 Section 1: Section 2.08.020 of the Riverside Municipal Code is amended as follows: 7 "Section 2.08.020 Offices, departments, divisions of departments, and office/department 8 heads established. 9 The following departments and department heads are established: 10 11 O. The Innovation and Technology Department, the head of which shall be the Chief 12 Innovation Officer. 13 P. The Housing and Human Services Department, the head of which shall be the Housing and 14 Human Services Director. 15 The Marketing and Communications Department, the head of which shall be the Marketing 16 and Communications Director." 17 The City hereby finds that this ordinance is not subject to review under the Section 2: 18 California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines sections 15060, 19 subdivision (c)(2) (the activity will not result in a direct or reasonably foreseeable indirect physical 20 change in the environment) and 15061, subdivision (b)(3) (there is no possibility the activity in 21 question may have a significant effect on the environment). In addition to the foregoing general 22 exemptions, the City Council further finds that this ordinance is categorically exempt from review 23 under CEQA under the Class 8 Categorical Exemption (regulatory activity to assure the protection of 24 the environment), CEQA Guidelines section 15308. 25 Section 3: The City Clerk shall certify to the adoption of this ordinance and cause 26 publication once in a newspaper of general circulation in accordance with Section 414 of the Charter 27 of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its 28 adoption.
