WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the title changes to the existing Wastewater Maintenance Mechanic and Revenue Representative classifications.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are hereby amended to 1) approve the creation of the new classifications and salary ranges for the Wastewater Maintenance Mechanic I and the Senior Treasury Representative; and 2) approve the title changes to the existing Wastewater Maintenance Mechanic and Revenue Representative classifications, all as set forth in Exhibit "A" attached hereto and incorporated herein by reference.
