

# **THIRD AMENDMENT TO SERVICES AGREEMENT**

## **AMERICAN FORENSIC NURSES, INC.**

### **Biological Evidence Collection**

#### **RFP 2124**

This THIRD AMENDMENT TO SERVICES AGREEMENT (“Third Amendment”) is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and AMERICAN FORENSIC NURSES, INC., a California corporation (“Contractor”), with respect to the following:

#### **RECITALS**

WHEREAS, on March 2, 2022, City and Contractor entered into Services Agreement (“Agreement”) for Biological Evidence Collection; and

WHEREAS, Section 2 of the Agreement states that the term may be extended for two (2) additional one-year terms not to exceed two (2) years, upon mutual written agreement of City and Contractor; and

WHEREAS, Section 3 of the Agreement states that if the term of the Agreement is extended, Contractor’s compensation for the extended term shall be mutually agreed upon in writing by the parties; and

WHEREAS, City and Contractor entered into a First Amendment to Services Agreement for Biological Evidence Collection dated March 2, 2022; and

WHEREAS, City and Contractor entered into a Second Amendment to Services Agreement to extend the term of the Agreement for a one (1) year period ending June 30, 2025 (“second extended term”), and agreed to new compensation amount not to exceed Seventy-Seven Thousand Dollars (\$77,000) dated July 12, 2024; and

WHEREAS, City and Contractor desire by this Third Amendment to increase the compensation from Seventy-Seven Thousand Dollars (\$77,000) to a total sum not to exceed One Hundred Three Thousand Dollars (\$103,000); and

WHEREAS, City and Contractor desire by this Third Amendment to increase the compensation for the current term in the amount not to exceed One Hundred Three Thousand Dollars (\$103,000.00).

**NOW, THEREFORE**, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. City shall pay Contractor for the performance of the Services during the third current term of the Agreement a total amount not to exceed One Hundred Three Thousand Dollars (\$103,000.00).

2. All other terms and conditions of the Agreement not inconsistent with this Third Amendment shall remain in full force and effect as if fully set forth herein.
