

SECOND AMENDMENT TO
PROFESSIONAL CONSULTANT SERVICES AGREEMENT

THIS SECOND AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Second Amendment") is made and entered into this _____ day of _____, 2023, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and NANCY K. BOHL, INC., a California corporation, doing business as THE COUNSELING TEAM INTERNATIONAL ("Consultant"), with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated August 4, 2023 ("Agreement"); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement dated _____, 2023 ("First Amendment"); and

WHEREAS, the City and Consultant would like to amend the Agreement to increase the contract amount by Sixty-Three Thousand Eight Hundred Forty-Eight Dollars (\$63,848.00) not to exceed One Hundred Seventy-Five Thousand Five Hundred Twenty Dollars (\$175,520.00) for Police, Human Resources and Fire Services, for the term July 10, 2023, through June 30, 2024.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. Section 3, Compensation/Payment, is hereby amended to increase the contract amount by Sixty-Three Thousand Eight Hundred Forty-Eight Dollars (\$63,848.00) not to exceed One Hundred Seventy-Five Thousand Five Hundred Twenty Dollars (\$175,520.00) for Police, Human Resources and Fire Services, for the term July 10, 2023, through June 30, 2024.

2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Second Amendment, shall remain in full force and effect as if fully set forth herein.
