

# 2025 WORKPLAN UPDATE


## - GOAL 1 -

# 2025 WORKPLAN UPDATE


## - GOAL 3 -

Commissioners continuously present ideas and explore ways to secure additional funding for Parks, Recreation and Community Services events, facilities, and improvements.




# 2025 WORKPLAN UPDATE

Commissioners regularly attend, participate in, or visit Parks, Recreation and Community Services events to demonstrate their support and remain actively engaged with the community.




# 2025 WORKPLAN UPDATE

On September 15, 2025, The Office of Sustainability presented information on Climate Change Impacts to the Commission.






