

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, WAIVING THE FORMAL BIDDING
4 PROVISIONS OF SECTION 1109 OF THE CHARTER OF THE CITY OF
5 RIVERSIDE UNDER THE UTILITIES PROJECT EXCEPTION THEREIN
6 FOR THE SELECTION OF HARDY & HARPER, INC. FOR
7 THE ASPHALT AND CONCRETE REPAIR SERVICES FOR WATER
8 SYSTEM MAINTENANCE.

9 WHEREAS, the Riverside Public Utilities Department ("RPU") is responsible for operating
10 and maintaining nearly 993 miles of underground water pipelines and over 67,000 water service
11 laterals; and

12 WHEREAS, each year, RPU's Water Field Forces ("Water Crews") complete approximately
13 1,200 routine and emergency water pipeline and service lateral repairs; and

14 WHEREAS, Water Crews also conduct various routine and emergency maintenance
15 activities to reduce or prevent more extensive repairs in the future; and

16 WHEREAS, once the water pipelines and service laterals are repaired, the damaged asphalt
17 and/or concrete must be replaced in accordance with the Riverside Public Works Department's
18 ("Public Works") Standards; and

19 WHEREAS, Water Crews are not equipped to perform street paving and therefore rely on
20 the Public Works Service Division ("Public Works Crews") to perform the asphalt and concrete
21 repair work related to water service maintenance; and

22 WHEREAS, in recent years, Public Works Crews have not had the personnel, experienced
23 significant equipment breakdowns, or were assigned other priority work which led to a backlog of
24 approximately 4,000 or more asphalt repair locations; and

25 WHEREAS, Public Works and RPU staff recommended hiring a contractor to handle
26 outstanding and future repairs on an on-call basis; and

27 WHEREAS, the benefits offered by a contractor include the ability to allocate dedicated
28 personnel, having ample and specialized equipment, and the ability to implement permanent repairs
in a timely and efficient manner; and

1 WHEREAS, on September 26, 2023, Riverside’s Purchasing Division issued Request for
2 Proposals (“RFP) No. 2289 for a qualified vendor to perform asphalt and concrete repair services
3 related to water system maintenance in an amount not to exceed One Million Five Hundred
4 Thousand Dollars (\$1,500,000.00) annually for a three-year term; and

5 WHEREAS, on October 19, 2023, the City received seven (7) proposals in response to the
6 RFP; and

7 WHEREAS, Public Work and RPU evaluated the proposals and Hardy & Harper, Inc.
8 ranked the highest; and

9 WHEREAS, Public Works staff have the expertise of overseeing paving contractors and will
10 partner with RPU to lead and oversee the work on the on-call paving contract; and

11 WHEREAS, City Charter section 1109 provides that the City Council may, by at least five
12 affirmative votes, waive the formal bidding requirements for projects for the construction and/or
13 improvement of any public utility system operated by the City, which includes wastewater and storm
14 drain systems.

15 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
16 California, based upon the reasons set forth herein and in the accompanying staff report and
17 presentation, as follows:

18 Section 1: The formal competitive bidding requirements of Section 1109 of the Charter of
19 the City of Riverside are hereby waived under the utilities project exception stated therein.

20 Section 2: The City Manager, or his designee, is authorized to execute the
21 Master Agreement and to approve the appropriate change orders with Hardy & Harper, Inc., in
22 order to perform asphalt and concrete repair services related to water system maintenance, in an
23 amount not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000.00).
