A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AUTHORIZING THE CITY OF RIVERSIDE TO RECEIVE THE DEPARTMENT OF CALIFORNIA HIGHWAY PATROL'S 2025/2026 CANNABIS TAX FUND GRANT PROGRAM AWARD IN THE AMOUNT OF \$257,965.47; AND AUTHORIZING THE EXECUTION OF NECESSARY GRANT DOCUMENTS BY THE CITY MANAGER, OR HIS DESIGNEE.

WHEREAS, the City of Riverside, by and through the Riverside Police Department ("RPD"), has applied for the Department of California Highway Patrol Cannabis Tax Fund Grant Program award in the amount of Two Hundred Fifty-Seven Thousand Nine Hundred Sixty-Five Dollars and Forty-Seven Cents (\$257,965.47) for fiscal year 2025/2026 ("Grant Award") for the education, prevention, and enforcement of laws related to driving under the influence; and

WHEREAS, the City Council of the City of Riverside desires to approve the City of Riverside to receive the Grant Award and to authorize the City Manager and his designees to execute all necessary grant documents, including any grant agreements, to effectuate the acceptance of the Grant Award.
