WHEREAS, the City and Consultant desire to increase compensation in the amount of Fifty-Four Thousand Eighty-Six Thousand Dollars and Ninety-Seven Cents (\$54,086.97), for a total revised contract amount not to exceed Four Hundred Fourteen Thousand Nine Hundred Sixty-Six Dollars and Seventy-Seven Cents (\$414,966.77); and

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Consultant agree as follows:

1. Paragraph 3, "Compensation/Payment", is hereby amended to increase compensation in the amount of Fifty-Four Thousand Eighty-Six Thousand Dollars and Ninety-Seven Cents (\$54,086.97), for a total revised contract amount not to exceed Four Hundred Fourteen Thousand Nine Hundred Sixty-Six Dollars and Seventy-Seven Cents (\$414,966.77).

All terms and conditions of the original Agreement not inconsistent with this First Amendment shall remain in full force and effect and are incorporated herein by this reference as though set forth in full.
