This FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT (“First Amendment”) is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and RHA LANDSCAPE ARCHITECTS-PLANNERS, INC., a California corporation (“Consultant”).

**RECITALS**

WHEREAS, on or about August 23, 2023, City and Consultant entered into that certain Professional Consultant Services Agreement, with compensation in the amount of Three Hundred Sixty Thousand Five Hundred Ninety-Seven Dollars and Eighty Cents (\$360,597.80) (“Agreement”); and

WHEREAS, the City and Consultant desire to increase compensation in the amount of Fifty-Four Thousand Eighty-Six Thousand Dollars and Ninety-Seven Cents (\$54,086.97), for a total revised contract amount not to exceed Four Hundred Fourteen Thousand Nine Hundred Sixty-Six Dollars and Seventy-Seven Cents (\$414,966.77); and

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Consultant agree as follows:

1. Paragraph 3, “Compensation/Payment”, is hereby amended to increase compensation in the amount of Fifty-Four Thousand Eighty-Six Thousand Dollars and Ninety-Seven Cents (\$54,086.97), for a total revised contract amount not to exceed Four Hundred Fourteen Thousand Nine Hundred Sixty-Six Dollars and Seventy-Seven Cents (\$414,966.77).

All terms and conditions of the original Agreement not inconsistent with this First Amendment shall remain in full force and effect and are incorporated herein by this reference as though set forth in full.
