## SECOND AMENDMENT TO MEMORANDUM OF UNDERSTANDING FOR REIMBURSEMENT OF CROSSING GUARD SERVICES

## RECITALS

WHEREAS, on September 25, 2019, the City and District entered into that certain Memorandum of Understanding for Reimbursement of Crossing Guard Services ("Agreement"); and

WHEREAS, on March 4, 2024, the City and District entered into that certain First Amendment to Memorandum of Understanding for Reimbursement of Crossing Guard Services to add twelve (12) additional crossing guard locations, with the District to reimburse to the City One Hundred Percent (100%) of the costs for the additional locations ("First Amendment"); and

WHEREAS, the City and District desire to add the Summer Session to all the crossing guard locations, with the District to reimburse to the City One Hundred Percent (100%) of the costs for all locations for the Summer Session.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 3, Compensation, is hereby amended to replace Exhibit "B-1" with Exhibit "B-2", attached hereto and incorporated herein by this reference.
- 2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Second Amendment, shall remain in full force and effect as if fully set forth herein.
