

Following discussion, it was moved by Councilmember Cervantes and seconded by Councilwoman Plascencia to (1) adopt a Resolution authorizing the City Manager, or designee, to accept awarded grant funds and execute any and all agreements and award documents on behalf of the Riverside Public Library for the California State Library Budget Act of 2022 (AB 178) or the State of California Budget Act of 2023 (SB 101) Building Forward Library Infrastructure Grant Program Round 2 in the amount of \$10,000,000 with a California State Library grant required 25 percent City match commitment of \$2,500,000, including making minor and non-substantive changes to documents associated with the grant as necessary; (2) adopt a Resolution authorizing the City Manager, or designee to accept awarded grant funds and execute any and all agreements and award documents on behalf of the Riverside Public Library for the California State Library Budget Act of 2023 (SB 102) for the State Targeted Grant in the amount of \$4,500,000, including making minor and non-substantive changes to documents associated with the grant as necessary; (3) and upon receipt of the award, authorize the Chief Financial Officer, or designee, to record an increase in revenues in the amount of \$14,500,000, or the sum of the actual grant awards, and appropriate expenditures in the same amount in the Grants and Restricted Programs Fund, SPC Jesus S. Duran Eastside Library Project revenue and expenditure accounts; (4) authorize the Chief Financial Officer, or designee, to record a supplemental appropriation in the General Fund and interfund transfer in the amount of \$3,500,000 from the General Fund Infrastructure Reserves to the Capital Outlay Fund; and (5) authorize the Chief Financial Officer, or designee, to record a supplemental appropriation in the amount of \$3,500,000 in the Capital Outlay Fund, SPC Jesus S. 




