

ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA,  
AMENDING SECTION 1.17.121(A) OF THE RIVERSIDE MUNICIPAL  
CODE TO ADD CHAPTER 5.85 IN THE INCLUDED LIST, AND THE  
TITLE OF SECTION 9.40.120 OF THE RIVERSIDE MUNICIPAL CODE  
REGARDING APPEAL.

The City Council of the City of Riverside does ordain as follows:

Section 1: Section 1.17.121(A) of the Riverside Municipal Code is hereby amended as follows:

**“Section 1.17.121 Appeal procedure for Riverside Police Department review of business permits.**

A. Absent any contradictory procedure, the following appeal procedure applies to all appeals from the Riverside Police Department's review of business permits referred to in the following Chapters of this Code: (1) Chapter 5.28, (2) Chapter 5.40, (3) Chapter 5.52, (4) Chapter 5.80, (5) Chapter 5.85, ~~(65)~~ Chapter 5.90, ~~(76)~~ Chapter 5.95, ~~(87)~~ Chapter 6.24, ~~(98)~~ Chapter 9.40, and ~~(109)~~ Chapter 9.42.”

Section 2: The Table of Contents for Chapter 9.40 of the Riverside Municipal Code entitled “Adult-Oriented Businesses” is hereby amended to read as follows:

**“Chapter 9.40 – Adult-Oriented Businesses**

**Sections:**

**9.40.010 Legislative Purpose.**

...

**9.40.110 Suspension or revocation of adult-oriented business regulatory permits and adult-oriented business performer permits.**

**9.40.120 Appeal ~~of denial~~.**

**9.40.130 Adult-oriented business development and performance standards.**

...

**9.40.200 Severability.”**

Section 3: The title of Section 9.40.120 of the Riverside Municipal Code is hereby amended as follows:

Section 4: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.
