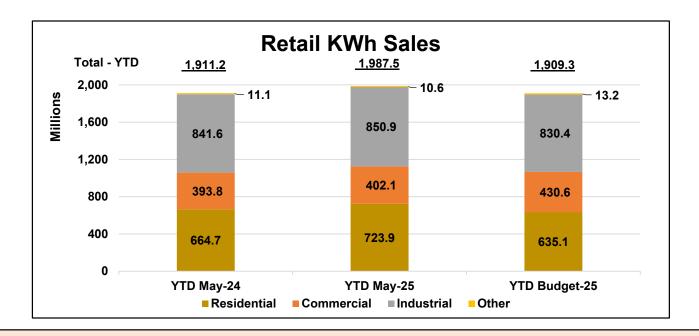

Revenues



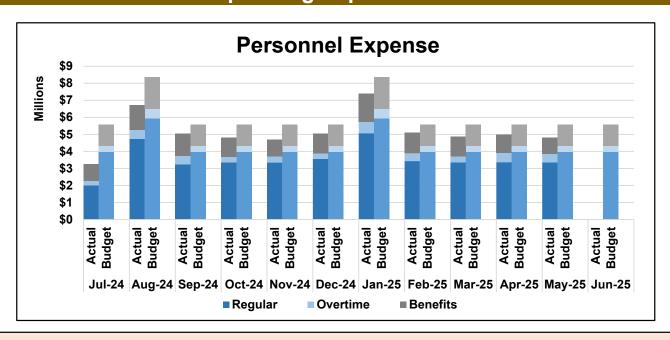
<u>Retail Sales:</u> Year-to-date retail sales of \$353.3M are \$6.0M (1.7%) higher than budget due to higher than anticipated consumption. Current year actual retail sales are \$31.6M (9.8%) higher than prior year due to an increase in rates as well as an increase in consumption compared to the prior year.



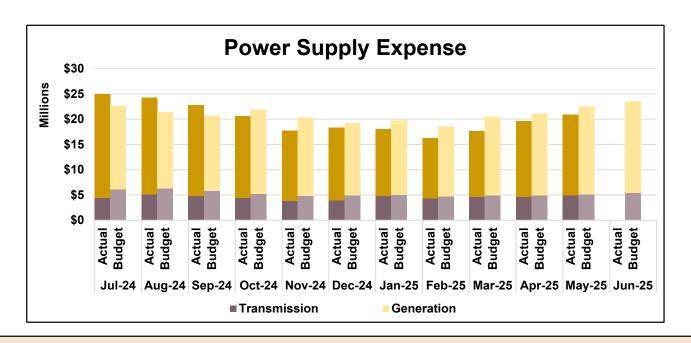
Retail KWh: Year-to-date retail KWh sales of 1,987.5M are 78.2M (4.1%) higher than budget due to higher than anticipated consumption, and 76.3M (4.0%) higher than prior year due to higher consumption compared to prior year.

Operating Expenditures



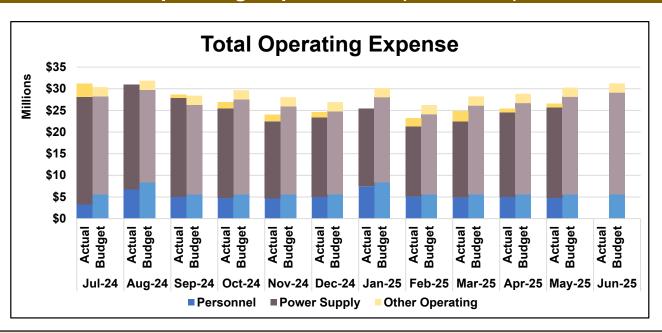
<u>Personnel Expense:</u> Year-to-date personnel costs of \$56.7M are \$10.1M (15.2%) lower than budget due to various vacancies and attrition.



<u>Power Supply Expense:</u> Year-to-date power supply costs of \$220.9M are \$7.5M (3.3%) lower than budget due to lower than expected transmission expenses.

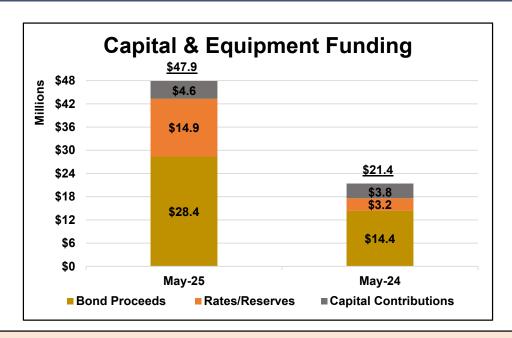

<u>Other Operating Expense:</u> Year-to-date other operating expenses of \$13.9M are \$9.9M (41.6%) below budget due to timing of expenses and savings in other general operating expenses.

Capital Improvement Program



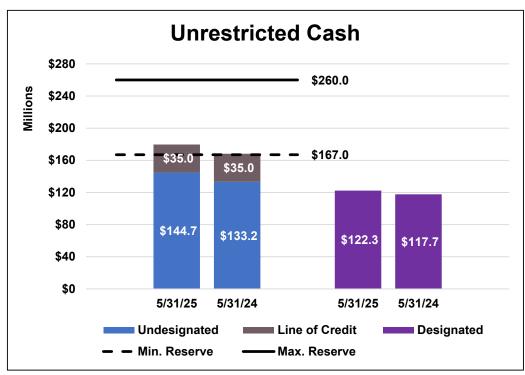
<u>Capital Expense:</u> Current year capital expenses (projects and equipment) of \$47.9M are higher than prior year by \$26.5M, reflecting increases of \$14.0M in bond proceeds, \$11.7M in rates and reserve funding, and \$0.8M in capital contributions. Ongoing work in significant capital projects to date includes substation, recurring, and underground project expenditures.

Cash Reserves

Reserves can be restricted by applicable laws and regulations or designated for specific purposes. Reserves that have not been restricted or designated are available to pay bills and provide cushion in the event of an emergency. The target levels for the undesignated reserve are established by City Council through reserve requirements for fiscal stability and are determined annually at 6/30 in conjunction with year-end financial results. The undesignated reserve of \$144.7M is \$11.5M higher than prior year primarily due to positive operating results. The undesignated reserve balance, combined with the available line of credit (LOC), is within the minimum and maximum levels at 5/31/2025.

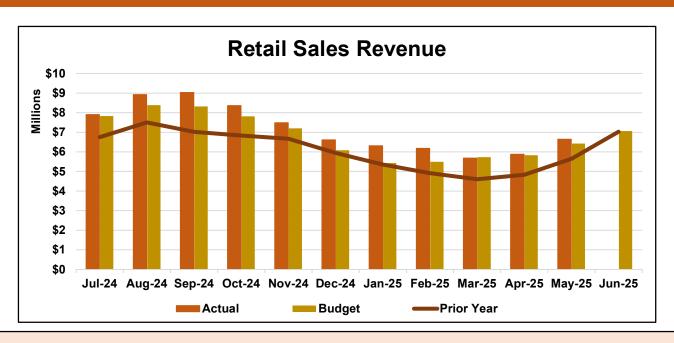

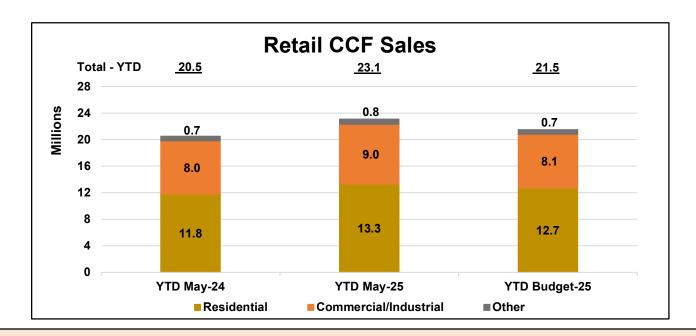

Revenues



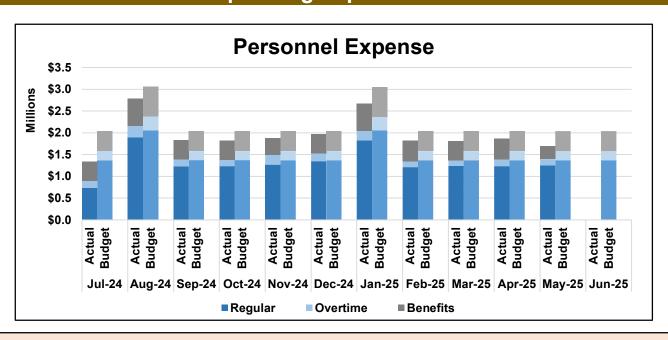
Retail Sales: Year-to-date retail sales of \$79.0M are \$4.5M (6.0%) higher than budget and \$12.9M (19.5%) higher than prior year primarily due to rate plan increases and increased consumption.



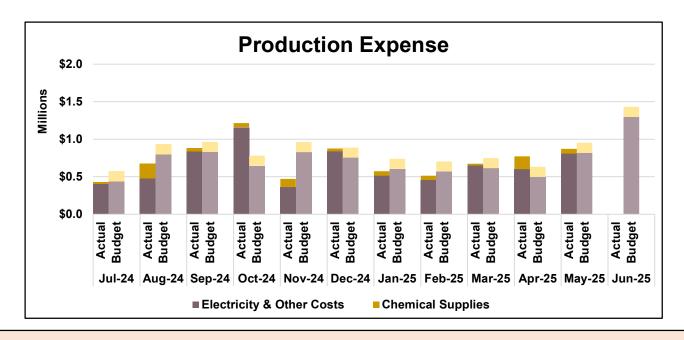
Retail CCF: Year-to-date retail CCF sales of 23.1M are 1.6M (7.4%) higher than budget due to higher-than-anticipated consumption, and 2.6M (12.7%) higher than prior year due to higher consumption compared to prior year.

Operating Expenditures



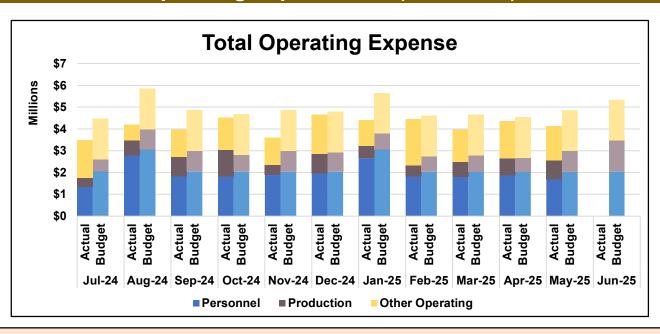
<u>Personnel Expense:</u> Year-to-date personnel costs of \$21.5M are \$3.0M (12.2%) below budget due to various vacancies and attrition.



<u>Production Expense:</u> Year-to-date production costs of \$7.9M are \$1.0M (11.2%) below budget due to lower-than-anticipated chemical and electricity costs for water production.

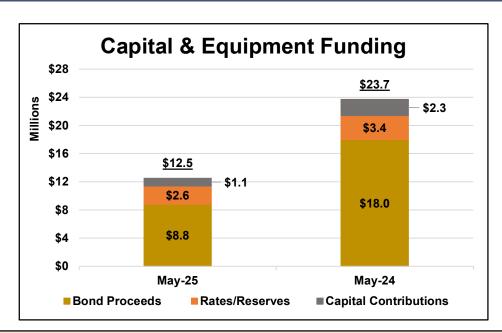

<u>Other Operating Expense:</u> Other operating expenses of \$16.3M are \$4.2M (20.5%) below budget primarily due to timing of expenditures and savings in other general operating expenses.

Capital Improvement Program



<u>Capital Expense:</u> Current-year capital expenses (projects and equipment) of \$12.5M are \$11.2M (47.3%) lower than prior year, reflecting decreases of \$9.2M in bond proceeds, \$1.2M in capital contributions, and \$0.8M in reserves. Ongoing work in significant capital projects to date is in distribution pipelines, transmission pipelines, and distribution facilities.

Cash Reserves

Reserves can be restricted by applicable laws and regulations or designated for specific purposes. Reserves that have not been restricted or designated are available to pay bills and provide cushion in the event of an emergency. The target levels for the undesignated reserve are established by City Council through reserve requirements for fiscal stability and are determined annually at 6/30 in conjunction with year-end financial results. The undesignated reserve of \$48.3M is higher than prior year by \$6.0M due to positive operating results and lower investment losses. The Water Utility's undesignated reserve balance, combined with the available line of credit, is within the minimum and maximum levels at 5/31/2025.
