

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AS THE SUCCESSOR AGENCY TO THE FORMER
4 REDEVELOPMENT AGENCY OF THE CITY OF RIVERSIDE
5 APPROVING THE SUBMISSION OF THE RECOGNIZED OBLIGATION
6 PAYMENT SCHEDULE FOR JULY 1, 2026 THROUGH JUNE 30, 2027.

7 WHEREAS, pursuant to the Health and Safety Code Section 34177, the City of Riverside as
8 the Successor Agency to the former Redevelopment Agency of the City of Riverside (“Successor
9 Agency”) is required to prepare a Recognized Obligation Payment Schedule (“ROPS”) for each fiscal
10 year; and

11 WHEREAS, each ROPS must include the amount and funding source for all payments required
12 during the period for all enforceable obligations of the Successor Agency; and

13 WHEREAS, pursuant to the Health and Safety Code Section 34186(a), the ROPS for the period
14 covering July 1, 2026 through June 30, 2027 (“ROPS 26-27”) includes all payments required and a
15 reconciliation of the estimated enforceable obligations versus the actual payments made under prior
16 ROPS; and

17 WHEREAS, upon approval by the Countywide Oversight Board, the ROPS 26-27 will be
18 submitted to the County Auditor-Controller, the State Controller’s Office, and the Department of
19 Finance in addition to posting it on the Successor Agency section of the City’s website.

20 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
21 California, as the Successor Agency to the Redevelopment Agency of the City of Riverside, as follows:

22 Section 1: Pursuant to the Health and Safety Code Section 34177, the Successor Agency does
23 hereby approve and adopt the ROPS 26-27 and upon approval of the same by the Countywide
24 Oversight Board is directed to transmit the ROPS 26-27 to the County Administrative Officer, the
25 County Auditor-Controller, and the Department of Finance, and post the same on the City’s website.
