INCREASE FISCAL YEAR 2023-2024 LEGAL BUDGET - LAW FIRM OF THOMPSON COBURN - PERCHLORATE GROUNDWATER CONTAMINATION LAWSUIT

The City Council approved (1) an increase of the annual legal budget for Fiscal Year 2023-2024 for the law firm of Thompson Coburn in an amount not-to-exceed \$205,000 for a revised total budget of \$763,000; (2) the annual legal budget for Fiscal Year 2024-2025 for the law firm of Thompson Coburn in an amount not-to-exceed \$720,000; and (3) the engagement of SL Environmental on a contingency fee basis for a perchlorate water contamination lawsuit.

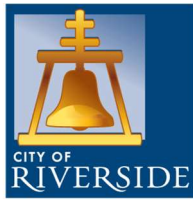
The Mayor and City Council appointed Elizabeth Scott-Jones to the Human Resources Board Ward 1 seat for a term through March 1, 2027.

STATE OF CALIFORNIA - CALIFORNIA ARTS COUNCIL GRANT FUNDS - SUPPLEMENTAL APPROPRIATION - RESOLUTION

The City Council (1) authorized a Resolution to accept \$500,000 from the California Arts Council to support arts education, musical instruments, equipment, and facilities projects to be implemented by the Riverside Arts Academy; (2) approved the Subrecipient Agreement with the Riverside Arts Academy, Inc., in the amount of \$500,000 to complete arts education, musical instruments, equipment, and facilities projects; (3) authorize the City Manager, or designee, to execute any and all agreements or associated documents associated with this project, including making minor and non-substantive changes and the contract extensions; and (4) authorized the Chief Financial Officer or designee, to record an increase in revenues in the amount of \$500,000, or in the amount of the grant award, and appropriate expenditures in the same amount in the Grants & Restricted Programs Fund, Riverside Arts Academy Project revenue and expenditure accounts; whereupon, the title having been read and further reading waived, Resolution No. 24126 of the City Council of the City of Riverside, California, Authorizing the Submission of an Application, and Acceptance of, Grant Funds from the State of California - California Arts Council, for the Implementation by the Riverside Arts Academy to Support Arts Education, Musical Instruments, Equipment and Facilities Projects, was presented and adopted.

U.S. DEPARTMENT OF HOMELAND SECURITY - FISCAL YEAR 2023 STATE HOMELAND SECURITY PROGRAM GRANT - SUPPLEMENTAL APPROPRIATION- RESOLUTION

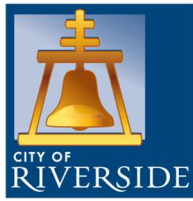
The City Council (1) adopted a Resolution authorizing the acceptance of a grant award from the U.S. Department of Homeland Security for the Fiscal Year 2023 State Homeland Security Program (SHSP) Grant program in the amount of \$45,677; and (2) authorized the Chief Financial Officer, or designee, to record an increase in revenue and appropriate expenditures in an amount equal to the grant award, in the Grants and Restricted Programs Fund, 2023 State Homeland Security Program Grant revenue and expenditures accounts; and (3) authorized the City Manager, or his designee, to execute the 2023 State Homeland Security Program Group, including making minor and non-substantive changes; whereupon, the title having been read and further reading waived, Resolution No. 24127 of the City Council of the City of Riverside, California, Authorizing the Submission of Application and Acceptance of Grant Award from the U.S. Department of Homeland Security Through the California Office of Emergency Services for the Fiscal Year 2023 State Homeland Security Program Grant (SHSP) and Authorizing the Execution of all Required Documents by the City Manager, or his Designee; and Amending the Budget for Fiscal Year 2023-2024 Accordingly, was presented and adopted.

REJECT BID 8068 - SOUTH TERMINAL AND GENERAL AVIATION APRONS REHABILITATION PROJECT - RIVERSIDE MUNICIPAL AIRPORT

The City Council (1) rejected all bids for Request for Bids 8068 for the South Terminal and General Aviation Aprons Rehabilitation Project located at the Riverside Municipal Airport; and (2) authorized staff to release a revised Request for Bids.

BID 8091 - 2024 MODEL YEAR FORD MAVERICK XLT LIGHT-DUTY TRUCKS - SUPPLEMENTAL APPROPRIATION

The City Council (1) awarded Bid 8091 to Fritts Ford, Riverside, for the purchase of eight 2024 model year Ford Maverick XLT light-duty trucks for the Community Development Code Enforcement Division in the amount of \$265,918.88; and (2) authorized the Chief Financial Officer, or designee, to record a supplemental appropriation in the amount of \$30,000 in the Central Garage Fund from available Working Capital to the Motor Pool, Automotive Equipment expenditure account.

PURCHASE ORDER - REPAIR PLAYGROUND RUBBER SAFETY SURFACING FOR PARK SITES

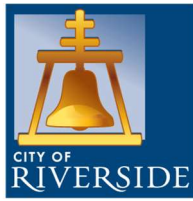

AGREEMENT AMENDMENT - LANDSCAPE MAINTENANCE SERVICES - CITY NEIGHBORHOOD PARKS

CHANGE ORDER TO PURCHASE ORDER 213444 - DESIGN INTERCONNECTION SYSTEM

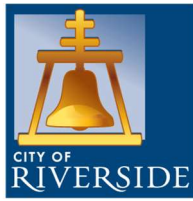

MASTER COOPERATIVE AGREEMENT - DESIGN, CONSTRUCTION, INSPECTION AND MAINTENANCE - WOODCREST-RINEHART ACRES DRAINAGE PLAN IMPROVEMENTS PROJECT

The City Council (1) approved the Master Cooperative Agreement with the Riverside County Flood Control and Water Conservation District for the Design, Construction, Inspection and Maintenance of Minor Drainage Facilities; (2) approved the Woodcrest-Rinehart Acres Drainage Plan Improvements Project Description Exhibit No. 1; and (3) authorized the City Manager, or designee, to execute the Master Cooperative Agreement with the Riverside County Flood Control and Water Conservation District and Project Description Exhibit No. 1, including making minor and non-substantive changes.

AGREEMENT AMENDMENT - MEMORANDUM OF UNDERSTANDING AMENDMENTS - FISCAL YEAR 2024-25 AND 2025-26 - CROSSING GUARD SERVICES

The City Council (1) approved the Third Amendment to Professional Consultant Services Agreement with All-City Management Services (ACMS), Inc., Santa Fe Springs, for Crossing Guard Program Management Services to add seven additional guard locations for a total of 84 guard locations through June 30, 2026, in the amount not-to-exceed \$1,776,768 for Fiscal Year 2024-25 and for an amount not-to-exceed \$1,853,376 for Fiscal Year 2025-26; (2) authorized the City Manager, or designee, to execute the Third Amendment to the Professional Consultant Services Agreement with ACMS, including making minor and non-substantive changes, and adding or removing crossing guard locations, subject to the availability of budgeted funds; (3) approved the First

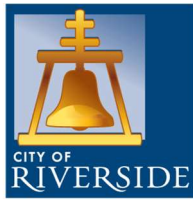

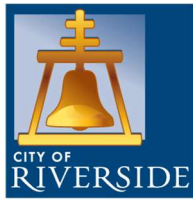

CRIDGE STREET RAIL CROSSING QUIET ZONE - CONSTRUCTION AND MAINTENANCE AGREEMENTS - CRIDGE STREET RAIL CROSSING IMPROVEMENTS

Following discussion, it was moved by Councilmember Falcone and seconded by Councilmember Cervantes to (1) approve the Grade Crossing Improvements Construction and Maintenance Agreement with Burlington Northern Santa Fe Railway Company (BNSF) for the Cridge Street rail crossing improvements in the amount of \$4,736,444.84; (2) approve the Construction and Maintenance Agreement for Cridge Street Highway-Rail At-Grade Crossing with Southern California Regional Rail Authority (SCRRA) in the amount of \$1,079,804.00; (3) approve the Authorization and Reimbursement Agreement with Union Pacific Railroad Company (UP) for the Cridge Street rail crossing improvements in the amount of \$520,240.00; (4) authorize the Chief Financial Officer, or designee, to record a transfer in the amount of \$2,250,000 in surplus Measure A funds from the Misc Railroad Project Management account to the BNSF/UP QZ-Panorama/Cridge account; and (5) authorize the City Manager, or designee, to execute the railroad agreements with BNSF, SCRRA, and UP, including making minor and non-substantive changes.
