**SUBJECT: AIRPORT MANAGER'S OPERATIONS AND ACTIVITY REPORT**

**ISSUE:**

Receive the January 2026 Airport Manager's Operations and Activity Report, which includes January-October 2025 aircraft operations data, October 2025 financial data, and review of airport highlights and events.

**RECOMMENDATIONS:**

That the Airport Commission receive this January 2026 Airport Manager's Operations and Activity Report.

**BACKGROUND:**

The Airport Manager's Operation and Activity Report is provided to inform the Airport Commission (Commission) about operations, City Council actions, events, meetings and other issues concerning the Riverside Municipal Airport (Airport).

**DISCUSSION:**

This update includes information about Airport operations, financials, and highlights.

Flight activity was fairly flat (-0.4%) for the month of October 2025, compared to October 2024. During the January through October time period, flight activity was down 6.4% in 2025 compared to that same time period in 2024. Even so, the Airport averaged almost 400 operations per day during October.

Four months into the current fiscal year, expenditures are tracking more than 14% below budget, while revenues are 8.6% below budget. Expenditures will track closer to budget with the completion of several upcoming projects (terminal exterior painting and marquee installation) funded from the operating budget, whereas revenues will likely begin tracking above budget as additional revenues are realized from advertising revenue, etc.


## Highlights

### *Planes and Treats 2025*

Held on October 18, Planes and Treats 2025 had an estimated 12,000 participants. Nearly 30 aircraft handed out 2,100 pounds of candy to hungry trick or treaters from 5:00pm to 9:30pm. This community-friendly event is always well-received and with the City's partnership this year, it was elevated as a city-sponsored event.

### *Taxiway A Rehab*

On Monday night, October 20, the Taxiway A Rehabilitation project began. The first phase of the project was completed in five days, consisting of markings removal, pavement crack fill, asphalt slurry sealcoat, and painting of temporary markings. In approximately 30 days, the contractor will return to paint permanent markings with glass beads and replace several airfield signs.



### Master Plan

The Airport Master Plan Update recently kicked off with an airport visit by the consultant on November 3 and 4. This visit consisted of a meeting with airport staff, airfield tour, Tower tour, FBO Tour, CBU Flight school tour, and meetings with Nextgen Flight Academy, Riverside Flight Academy, Waypoint Aviation, CAVU, and Maintenance One. The first Planning Advisory Committee (PAC) Meeting was held on November 4, 2025. The consultant has established a website for the community to learn more about the Master Planning process. <https://ral.airportstudy.net>.

### Name Change

As the Airport continues to evolve with airfield improvements, terminal improvements, and staffing improvements, a brand refresh is occurring. Thus far:

1. A compass rose has been painted on the ramp north of the terminal.
2. A new logo has been designed.
3. Graphic wraps have been installed on the front of the terminal.
4. Banners have been installed on light poles facing the ramp.
5. New stationary has been designed.
6. New business cards have been designed.
7. A formal name change process (from Riverside Municipal Airport to Riverside Airport) has been initiated with the FAA and Caltrans.

In the future:

1. A new marquee will be installed at the airport entrance.
2. The exterior of the Terminal will be painted.
3. New jackets and shirts will be ordered for staff.
4. A new RAL sign will be installed in front of the Terminal.

Airport Pavement Management System (APMS) at the Riverside Municipal Airport; and Authorizing the Execution of all Necessary Documents Related to such Grant

- FAA Grant 3-06-0200-038-2025, A Resolution of the City Council of the City of Riverside, California, Authorizing the Application and Acceptance of Grant Funds of \$283,366 from the Federal Aviation Administration for the Design Phase of Runway 9-27 Runway Safety Area Erosion Control Project at the Riverside Municipal Airport; and Authorizing the Execution of all Necessary Documents Related to Such Grant

### **Upcoming City Council Actions**

- Mead and Hunt Supplemental to increase Master Consultant Agreement amount from \$500,000 to \$1 million.
