CONSENT CALENDAR

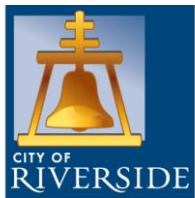
It was moved by Commissioner Moti with and seconded by Commissioner Kwasman. The motion was carried.

MOBILITY AD HOC COMMITTEE

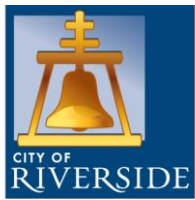
Commissioner Kwasman announced there was nothing to report at this time.
