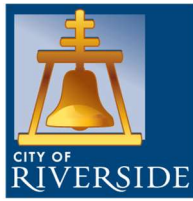

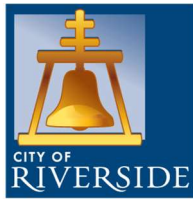

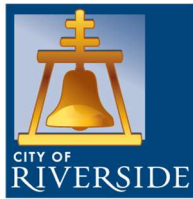

VEHICLE MILES TRAVELED MITIGATION BANK PROGRAM - ESTABLISH MITIGATION FEE - RIVERSIDE MUNICIPAL CODE TITLE 16 AMENDMENT - RESOLUTIONS - ORDINANCE INTRODUCED

Public Hearing was called to consider adopting a Resolution approving the Vehicle Miles Traveled (VMT) Mitigation Bank Pilot Program and establishing a voluntary mitigation fee, introduce an Ordinance amending Title 16 of the Riverside Municipal Code by adding Chapter 16.80 regarding the VMT Mitigation Bank Pilot Program, and adopt a Resolution amending the VMT threshold for California Environmental Quality Act (CEQA) compliance related to transportation analysis. Seven people spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Robillard and seconded by Councilmember Mill to (1) adopt a Resolution approving the Vehicle Miles Traveled (VMT) Mitigation Bank Pilot Program and establishing a mitigation fee, recommending Option A (VMT Mitigation Bank Option) and associated bike projects detailed within the VMT Mitigation Program Report; (2) introduce an Ordinance, amending Title 16 of the Riverside Municipal Code by adding Chapter 16.80 related to Vehicle Miles Traveled (VMT) Mitigation Program; (3) adopt a Resolution modifying the existing California Environmental Quality Act (CEQA) VMT transportation Impact threshold to match the current jurisdictional baseline VMT per capita for new residential projects and the current jurisdictional baseline VMT per employee for new office and industrial projects and revise the Traffic Impact Analysis (TIA) Guidelines accordingly; and (4) direct staff to conduct a workshop to educate the development community in the application of the new vehicle miles traveled mitigation program including a training session on the TredLite software to address projects with transportation related VMT impacts. 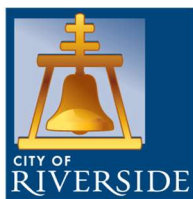

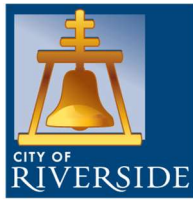

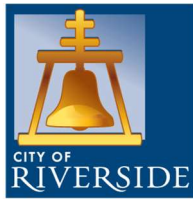

MASTER FRINGE BENEFITS AND SALARY PLAN AMENDMENT - RESOLUTION

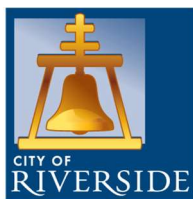

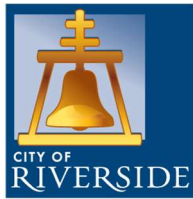

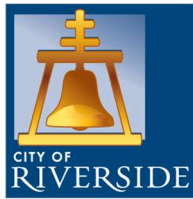

BID 8105 - VICTORIA AVENUE AND PLEASANT STREET STORM DRAIN CONSTRUCTION - FUND TRANSFER

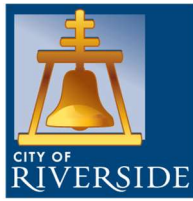
